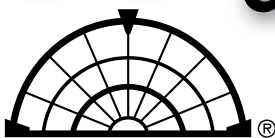

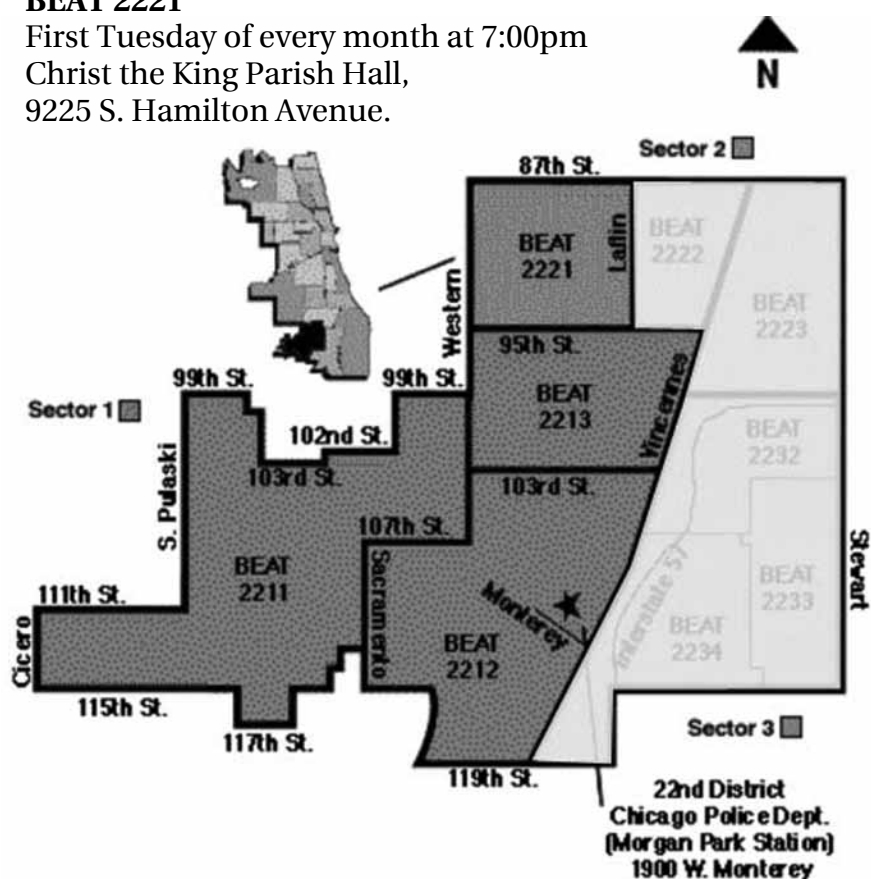

As you can see, all play structures and soft surface has been installed. Much of the area around the park requires landscape restoration, we hope the finishing touches can be completed before the ground freezes and work must stop for the year.



Answer the Call: Become a Chicago Police Officer

The City of Chicago recently announced a new test will be offered for anyone interested in becoming a Chicago Police Officer. Information regarding administration of the written examination will be available during the application period, which runs from October 28, 2010 through November 26, 2010. NOTE: Only a percentage of those applicants taking the written examination will be eligible to participate in additional steps of the hiring process.

Applicants who meet the minimum qualifications and pass the test will be placed on a pre-qualified applicant list based on a lottery. Those applicants will be called for further processing as positions become available.

Applicants must pass a background investigation; medical examination; psychological assessment; drug screens; physical fitness tests and other pre-employment procedures as determined by the Chicago Police Department before they are eligible for hire.

The Power Test

The Police Officer Wellness Evaluation Report (POWER Test) is administered to applicants several times during the hiring process and to probationary officers while attending the Training Academy. Failure of any administration of the POWER test will lead to disqualification from the hiring process or termination from the Academy.

The Training Academy

At the Training Academy, probationary police officers receive physical, practical and academic training on, among other things, CPD policies and procedures; the law; communication skills; strategies and tactics; professionalism; and the

use of various technologies. Probationary police officers must successfully pass all phases of training at the Academy in order to qualify for field training.

19th Ward to Host Property Tax Payer Assistance Meeting

The Second Installment 2009 Property Tax payments are due in December 2010 at the Cook County Treasurer's Office or Chase Bank. On Saturday December 4, 2010 Alderman Ginger Rugai & Committeeman Matt O'Shea will host a taxpayer assistance meeting at the Chicago High School for Agricultural Sciences from 9am-12pm. At that time, Representatives from the Chicago Tax Assistance Center (CTAC) will be present to assist homeowners with their tax bills. CTAC representatives will check to ensure that homeowners have applied for all of their eligible property tax exemptions and will assist in the filing of Certificate of Error forms should there be missing exemptions.

This meeting is especially important for senior citizens who may not be receiving the proper exemptions. If you cannot attend the event, please visit CTAC in Room 100, City Hall, 121 N. LaSalle St. (open weekdays from 8:30 a.m. to 5 p.m.) or call 311 for assistance with property tax questions.



Rebates & Tax Credits Available for Energy Efficient Products

It takes a lot of energy to heat your home. In today's tough economy, that can also mean a lot of money. Currently, there are a variety of programs available to help residents increase the energy efficiency of their homes and lower natural gas bills.

The Chicagoland Natural Gas Savings Program, funded by ratepayers of Peoples Gas and North Shore Gas, offers cash rebates to eligible customers for ENERGY STAR-qualified products. Rebates are available for energy efficient attic insulation, storage water heaters, and high efficiency gas furnaces and boilers. Rebates range from \$50 - \$750 per item and you can receive rebates on multiple items in one home. These rebates will end on May 31, 2011 or when funds are depleted so homeowners are encouraged to act now. In addition to the Natural Gas Savings Program, the federal government also offers tax credits for the purchase of many energy efficient products for your home. Credits are available for many heating, ventilating, air conditioning (HVAC) systems, insulation, roofs (metal or asphalt), non-solar water heaters, windows and doors. Through the energy star tax credit program, homeowners receive a federal tax credit of 30% of a products total cost up to \$1500 if purchased in 2010. 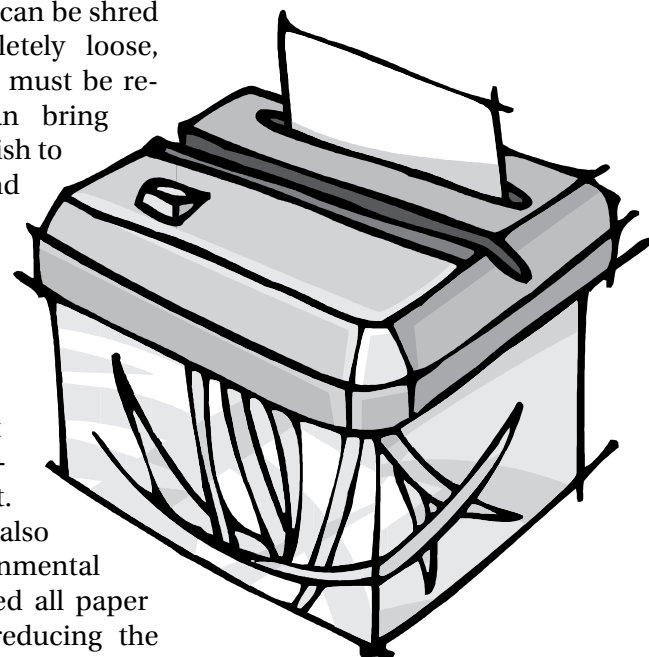
19th Ward to Host Document Shredding Day

Following an incredibly successful document shredding day in September, Alderman Ginger Rugai, Committeeman Matt O'Shea and Midway Document Destruction will again host a free paper shredding day for residents of the 19th Ward on December 4th at the Chicago High School for Agricultural Sciences Parking lot, 3857 W. 111th Street, from 9:00am-12:00pm.

Before documents can be shred they must be completely loose, any staples or binders must be removed. Residents can bring any documents they wish to shred to the school and load them into a plastic cart. The carts are then loaded into the truck and shredded on sight.

Document shredding is one of the most effective tools in preventing identity theft. Shredding documents also has positive environmental impacts; once shredded all paper is recycled, thereby reducing the

amount of waste in landfills. All 19th Ward residents are invited to participate in this shredding day at the Chicago High School for Agricultural Sciences parking lot on December 4th. 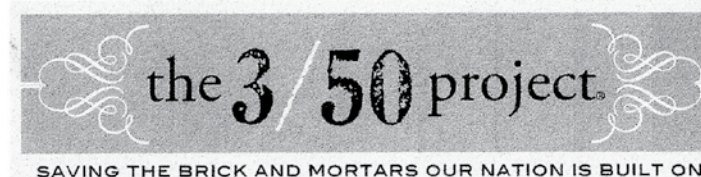

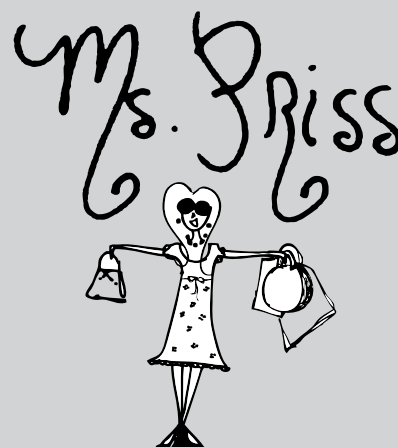

Holiday traditions that spark memories



Whether your family gets together to bake, hang stockings or watch Jimmy Stewart discover his wonderful life, holidays rituals become traditions that inspire memories, teach lessons and bring families together year after year. Here are a few stories of holiday traditions recalled by residents of Smith Village, a continuing care retirement community at 2320 W. 113th Place in Beverly.

Anticipation feeds excitement

For Betty Fish, the family's Christmas morning tradition was an exercise in learning patience. That's because Betty and her sister, Peggy, were not allowed to see the tree until they ate breakfast—and her parents made sure the girls didn't sneak a peek by draping fabric across the archway that lead to the living room. Betty remembers bolting down the stairs on Christmas morning and heading to the kitchen to hurry through breakfast. It took a lot of her willpower to refrain from pulling back the curtain for a glimpse at what lay under the tree.

The "wait until after breakfast rule" was one Betty attempted to implement while raising her own three children, but she had minimal success. Two of her children's excitement ruled but one daughter, who always savored sleeping late, had to be roused out of bed by her anxious siblings.

Betty's family holiday tradition also inspired a special Depression-era Christmas memory of when she was about eight years old. The draped archway hid a special gift, and after breakfast, Betty discovered a huge, shiny red automobile under the tree. This was the type she could pedal down the street—and the sight of this luxurious toy left her wide-eyed and speechless. On a Christmas morning decades later, she saw her granddaughter, Lotus, stand speechless with the same wide-eyed look after receiving a kitchen set scaled to suit the

child—and creating that expression in a child's eyes is as great a holiday tradition as any other.

Let traditions evolve

Monica Joria remembers going to bed on Christmas Eve only to have to wake in the middle of

the night to attend Mass at 3 a.m. at Visitation Catholic Church in Chicago's Englewood neighborhood. After Mass, the family returned home, ate breakfast, went back to bed and woke to open their gifts, which sat under their artificial tabletop tree. Later, the church moved the mass to midnight, which was a tradition that was carried on much more successfully.

"I have no idea why they held

mass at 3 a.m.," says Monica, "or why they stopped!" In the Joria household, the tradition changed. Everyone went to church and opened their gifts on Christmas morning—under a real tree.

The more the merrier

Betty Grant's great holiday tradition is a story of sharing. She grew up without a large extended family and always wished for a holiday dinner table packed with children, grandparents, aunts, uncles and cousins. So when she married Jack, Betty made sure everyone knew of her "open table policy," a standing invitation to anyone.

"No matter what we had, we always had enough to share—and I always felt good about that," recalls Betty. "Friends, neighbors and new acquaintances always knew they were welcome." One time, nearly 50 years ago, her sister, Fran, invited her girlfriend from Iowa, who also brought four sailors from Great Lakes Naval Base. They all had a fabulous time.

Betty never regarded serving dinner to 25 or more guests as a chore. Her open table enriched each holiday. It's a tradition she's passed along to her eight children,

who now take turns creating the celebrations Betty and her family found so rewarding.

These are only a few of the many memories holiday traditions inspire. Each family's rituals foster a togetherness built on rich, shared experiences that make holidays special.

Five tips to create treasured traditions

1. Foster fun and anticipation around the festivities; e.g., make tree-buying and decorating a family event, go caroling together, create your own ornaments.
2. Make sure everyone in the family, and those without family, are included.
3. Keep your traditions simple, such as baking or watching a favorite movie.
4. Select activities that are inexpensive.
5. Adjust your traditions to accommodate growing children or other changing circumstances.

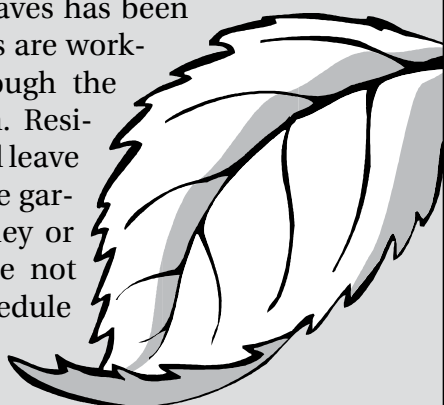

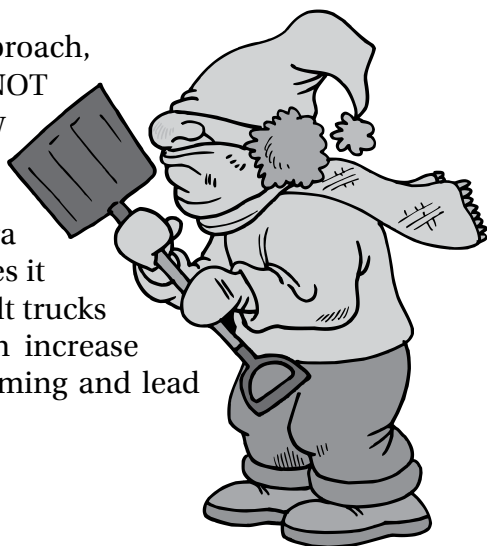
Yard Waste & Leaf Pick Up

Senator Ed Maloney Legislative Update

Since the adjournment of the legislative session in May, Senator Ed Maloney (D-Chicago) has spent the last five months actively pursuing numerous issues of importance in the 18th legislative district. These issues include improving access to higher education, tackling important health care issues, and preserving agriculture and the environment. Here are some of the specific initiatives that Senator Maloney has been working hard to accomplish in the recent months.

EDUCATION

SJR 88 - Higher Education Finance Study Commission

As Chairman of the Senate's Higher Education Committee, Senator Maloney knows firsthand the tremendous obstacles facing higher education in Illinois. Most notably is the problem of financing; both in terms of the cost to attend and the cost for the state to fund these institutions.

In February Senator Maloney introduced Senate Joint Resolution 88, a legislative initiative that directs the Board of Higher Education to establish a Higher Education Finance Study Commission. The 11 members of this commission will examine the history and means of higher education funding in Illinois and compare the productivity of Illinois' higher education system to other state systems. The Commission will provide an analysis of best practices implemented in other states for incentivizing certificate and degree completion. Members will also review tuition and financial aid policies, and consideration alternative funding mechanisms.

The Commission will report its findings and recommendations to the Board of Higher Education, the Illinois Community College Board, and the Illinois Student Assistance Commission for adoption by these agencies. It will also provide this report to the General Assembly and the governor by December 1, 2010.

Senator Maloney has attended all five meetings of the Commission since the adoption of the resolution. During this time, the Commission has discussed the current policies in place and brought in national experts on higher education productivity, performance funding, and financial aid to help make improvements. The Commission's recommendations are intended to link the goals of the Illinois Public Agenda for College and Career Success to the state's higher education budgeting process.

In addition to serving on the Commission, Senator Maloney holds many additional higher education positions and honors. These include appointment to the Illinois Education Foundation, membership on the St. Xavier University School of Educational Advisory Board, and a serving as a commissioner on the Midwestern Higher Education Compact.

Senator Maloney spent time this summer working diligently on the Illinois Intergenerational Initiative. This program brings together older generations and young people to tackle today's issues in education, public policy, and community life. Through Maloney's involvement and support from the Illinois Board of Higher

Education, the program has fostered intergenerational engagement and leadership in schools and on campuses throughout Illinois.

HEALTH CARE

Senator Maloney met with local health care experts, medical professionals, and residents of the 18th District at a health issues forum sponsored by Christ Hospital in Oak Lawn. The health forum provided an opportunity for community leaders to discuss important issues facing the health care community, as well as an opportunity for residents to seek answers from the health care experts. The forum went very well and is expected to be held again next year.

Maloney was also named "Legislator of the Year" this year by the Illinois chapter of the National Multiple Sclerosis Society for his advocacy on this issue. He is also actively involved in the South Suburban American Cancer Society.

AGRICULTURE & ENVIRONMENT

Maloney has participated in the Illinois Farm Bureau's "Adopt-A-Legislator" program since 2004. The program links urban elected officials with local farm bureaus of rural communities. Senator Maloney is sponsored by the Stephenson County Farm Bureau. Each year, Senator Maloney provides trips to Stephenson County farms with residents from his district so that they can learn about the importance of agriculture to Illinois' economy.

In August, Senator Maloney spent a weekend in Stephenson County with 50 residents of his district, ex-



ploring the importance of agriculture to Illinois' economy. During the trip, the group had the opportunity to tour three working farms and see how milk, eggs, and other foods are produced.

Because of Maloney's commitment to improving agriculture in Illinois, in September he was presented with the "Friend of Agriculture" award by the Illinois Farm Bureau. The award is sponsored by ACTIVATOR, a program within the IFB that offers support to politicians who stand up for agriculture and protect the values of rural America.

Senator Maloney is also very concerned with environmental issues and is committed to making the 18th District the "greenest" legislative district in the state. Through his legislative support, the Village of Oak Lawn was able to secure a grant from the Department of Commerce and Economic Opportunity to establish a permanent Electronic Recycling collection program. The new collection site opened on October 9th and is located at the Village of Oak Lawn Public Works Garage (5532 W. 98th Street).

Tips for Avoiding Parking Tickets

The City of Chicago Department of Revenue has been regularly on the streets writing a wide variety of tickets for vehicles. Below, please see several tips for avoiding tickets.

Most restricted parking areas are clearly marked by signs or curb markings, like tow zones, residential permit parking, and fire hydrant violations. There are other restrictions, not necessarily indicated by signs that motorists are required to know. These violations include parking in a manner that impacts pedestrian safety, access for persons with disabilities, and traffic flow.

It is illegal to park on a sidewalk, parkway or crosswalk

While most motorists know this, some do not know that in a private driveway that requires a vehicle to drive over a public sidewalk you cannot park your vehicle in your driveway with its rear or front extending over the pedestrian sidewalk. This is illegal, in part, because your vehicle may be impeding the ability of a person in a wheelchair to travel without difficulty on the sidewalk. Further, pedestrians, including parents or caregivers with strollers, have the right to expect the public way to be fully clear of impediments like parked vehicles. Similarly, you cannot park with your wheels on the curb. Vehicles that park with two wheels on a curb can seriously damage the curb. Fur-

ther, many residents consider this practice unsightly.

Improper Display of City Sticker

Most residents know they are required to display current city stickers on their vehicles. What may be less widely known is that there are specific display requirements for city stickers. This means that many motorists will be required to remove expired stickers purchased in previous years. City law requires that your city sticker be placed on the inside of your vehicle on the lower right hand side of your windshield.

Parking a Vehicle for the Sole Purpose of Displaying the Vehicle for Sale, to make repairs, or to Sell Merchandise

You may not park your vehicle for the sole purpose of displaying it for sale, to make repairs or to sell merchandise. These restrictions promote quality of life, and the residential look to a community. Many residents feel that vehicles parked on the public way for these purposes are unsightly.

Parking In An Alley

While many motorists know that you are not allowed to park in an

alley because traffic flow may be obstructed, some are unaware that this includes parking in front of a garage. You cannot park your car in front of your garage because this can obstruct traffic flow and obstruct the ability of other motorists to maneuver in and out of their garages.

Wrong Direction or 12 Inches from the Curb

This parking restriction is actually a combination of two restrictions. It is illegal to park in the direction opposite to traffic flow. For example, most motorists are aware that a one way street requires you to park in the required direction of traffic. A lesser known restriction is

that you are still required to park your vehicle in the direction of traffic on a street that allows traffic in two directions. This restriction promotes the correct flow of traffic.

You cannot park your vehicle more than 12 inches from a curb. This restriction is designed to encourage the free flow of traffic by ensuring that vehicles are not impeded by parked vehicles that are too far out into the roadway. Vehicles sticking out too far into the

roadway also have a higher likelihood of being hit or scraped by passing vehicles.

Parking Outside Diagonal Markings

Chicago does have some parking spots that are marked by diagonal lines. You must park within these lines so that other motorists can park in spaces next to yours without difficulty.

Snow Route:

2 Inches of Snow or More

Snow routes are designated with signage by the City on streets with significant traffic flow. It is necessary for snow plows from the Department of Streets and Sanitation to have access to plow and remove snow from streets with significant traffic. The ability for the City to quickly remove snow from heavily traveled streets benefits all motorists and promotes safety and the free flow of traffic. If you are unsure about how much snow has fallen, err on the side of caution and park on a street without these posted restrictions.

Non-Compliant License Plates

State law requires most vehicles to affix front and back license plates to the vehicles at a height of not less than 12 inches from the ground. For example, you can be issued a ticket if you are displaying your license plate in your windshield.
