Every ten years, the federal government conducts a nationwide census to gather information about the national population. Upon the completion of the census, government entities are legally required to alter legislative district boundaries in accordance with population changes.

The Chicago City Council is in the process of shifting ward boundaries to reflect changes in population.

If the City's population were evenly distributed, each ward would have 53,912 residents. Currently, the 19th Ward's population is 52,647, slightly below the average. Unfortunately, wards that border ours fall well below that average are looking to absorb portions of our eastern edge to make-up the difference.

Residents living on the east end of our ward have been emphatic in their desire to remain part of the 19th Ward. The four civic associations affected have

organized letter writing campaigns and petition drives; many residents are displaying yard or window signs affirming their preference for the 19th Ward.

Diversity is one of the 19th Ward's greatest strengths; our residents are proud to live in one of the few truly integrated communities in Chicago. As long as resi-

dents seek to remain in the 19th Ward, we will work to maintain our boundaries. Our children learn in 19th Ward schools, play in 19th Ward parks, and read in 19th Ward libraries.

The City Council is hosting a series of public hearings on the proposed boundary changes. The meeting for our area will be held on Wednesday, November 9, 2011 in the auditorium at Morgan Park High School, 1744 W. Pryor Ave., at 6:00 pm. Please come out to voice your opinion on the re-map. Together we can keep our community in place.

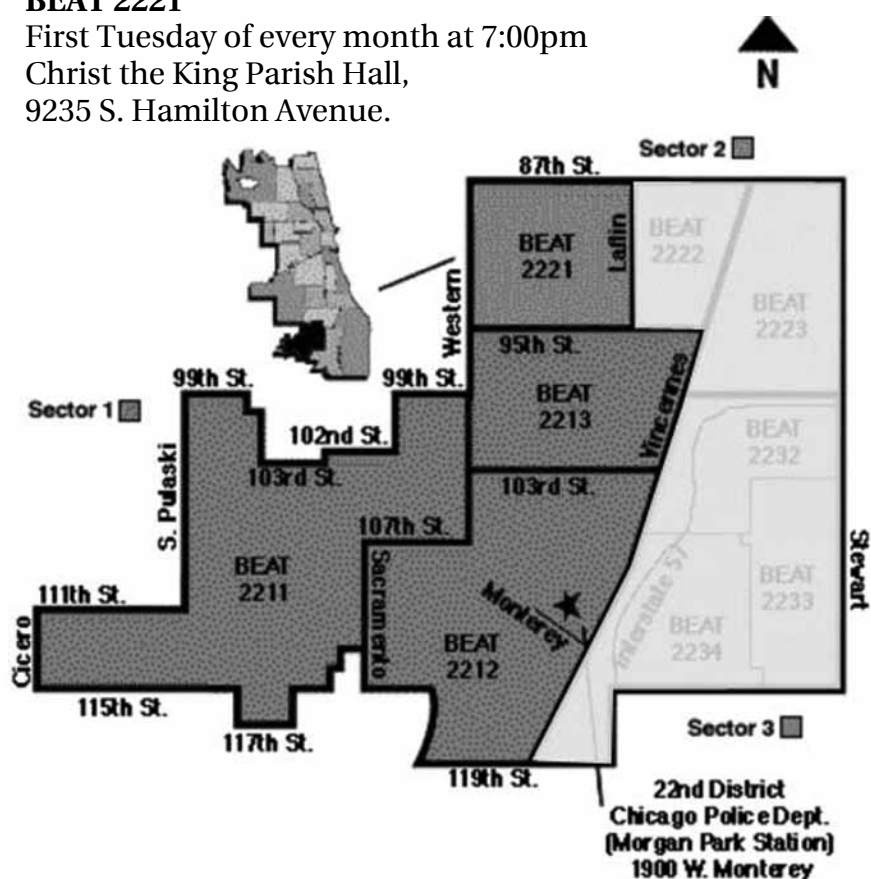

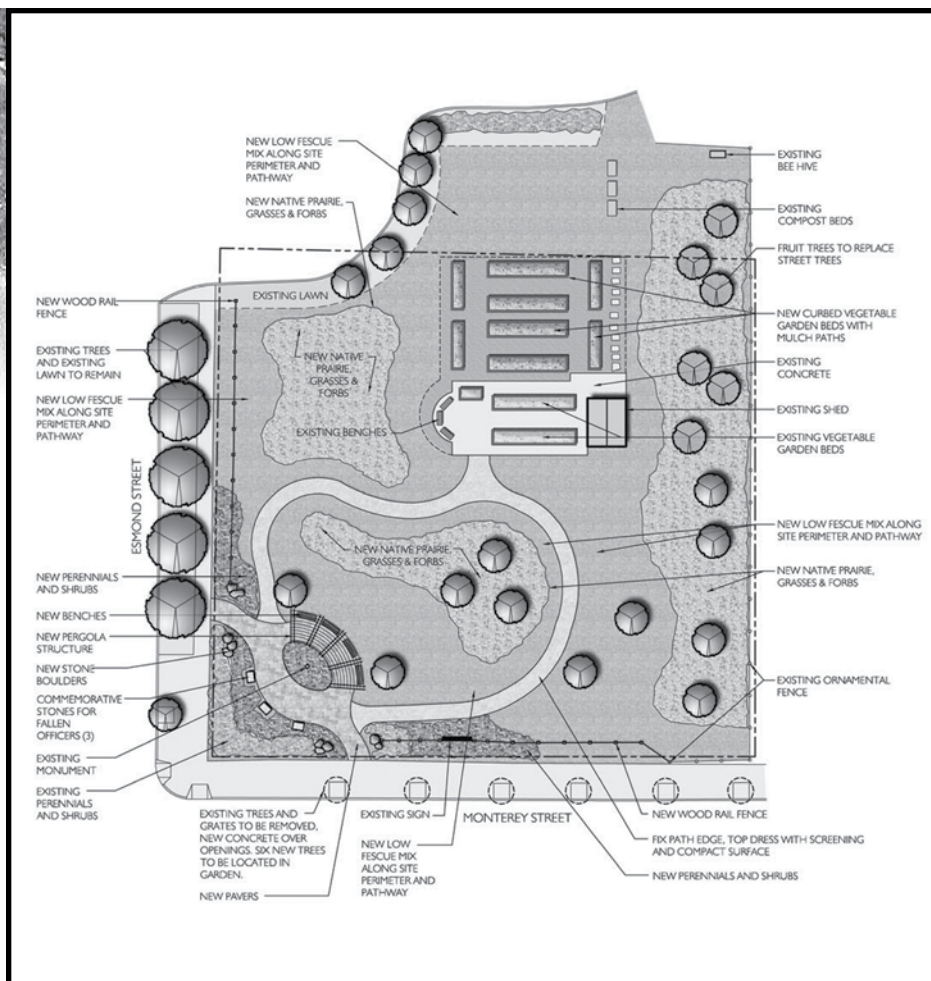


Plans to revitalize the Edna White Community Garden have been progressing. Recently, the Open Space Impact Fee Committee approved a substantial grant to upgrade the corner of the garden. Through these funds brick pavers, decorative pergolas, boulders, benches and gateway plantings will be installed. Other planned improvements include a slab fence, additional raised fruit and vegetable beds, and a controlled burn in the prairie grasses.

On Friday, November 11th, Garden Coordinator Kathy Figel is hosting an event to raise funds for these improvements and ongoing main-

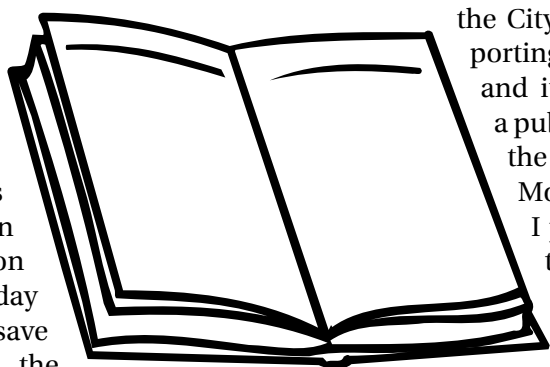

Proposed Library Cuts

Last month, Mayor Emanuel outlined his 2012 budget proposals. The plan calls for a reduction in library hours on Monday and Friday mornings to save \$6.6 million in the City budget. This decrease, while not insignificant, will allow all of our libraries to remain open and serving the residents of Beverly, Morgan Park, and Mt. Greenwood.



the City Council supporting our libraries and its staff during a public hearing on the 2012 budget. Moving forward, I pledge to continue working with the other Alderman to explore alternatives that may offset some of these cuts.

Libraries are an integral part of our community. After discussing these cuts with patrons and staff I vow to support them in everyway possible during the budget process. It is my hope that the final 2012 budget will include lesser cuts to libraries, maintaining their high levels of public service.

For many years our City's revenue has fallen significantly below our expenses. In the face of mounting economic difficulties, we must make the decisions necessary to stabilize our precarious financial standing. The final budget may be unpopular with the public, but it will force us to operate within our means.

As a parent of young children, I appreciate our branch libraries as vital community anchors. Libraries continue to serve as crucial education centers providing essential programs to children, adults, and seniors. However, our libraries are constantly evolving to meet the changing needs of Chicagoans.

In these challenging economic times, libraries have become resource centers to job seekers. In fact, this year alone, more than 60% of librarians' time was spent helping patrons apply for jobs. In 2011, thousands of residents attended free financial literacy programs or sent their children to free educational programs at neighborhood libraries in lieu of paying a fee for such assistance.

In recent years, many big city library systems have faced significant branch closures. While the proposed cuts will maintain all existing library branches, they will have a substantial impact on our community. On Friday, October 21st, I joined a large group of colleagues in

Community Updates

Sterling Bay Development at 91st & Western Ave.

Earlier this year, the Village of Evergreen Park & Sterling Bay Companies outlined plans to re-develop the 45 acres on the east side of the Evergreen Park Golf Course, located at 91st & Western Ave. The 450,000 square foot retail project includes Meijer and Menards, two mid-size retail locations, several smaller locations, a gas station, and 1900 parking spaces along Western Avenue between 91st St. and 93rd Pl. This development will significantly amplify our existing traffic congestion problems along Western Ave. and 95th Street.


KLOA, Inc., a well known traffic engineering firm, has conducted a traffic study to predict the impact of this project on our community. Seeking an independent opinion, I have forwarded their findings to the Chicago Department of Transportation (CDOT) for review. Additionally, I have asked all stakeholders in this project, including the Village of Evergreen Park, Sterling Bay Companies, the Illinois Department of Transportation and the Chicago Department of Transportation, to explore options to address the substantial traffic increase. Listed on

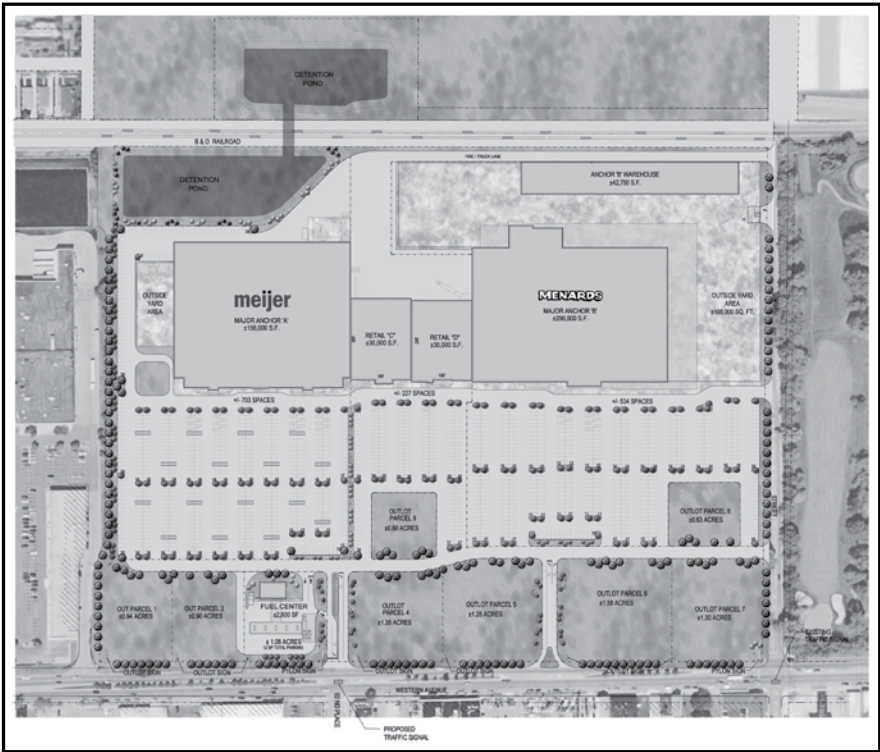

away from a groundbreaking. I have, and will continue to use this time to thoroughly examine the numerous concerns and ensure all proper precautions are taken. Traffic Management

Creating a road inside the parking lot linking the new development to existing shopping centers to the south. This would allow west bound traffic to bypass Western Avenue and access 95th Street through existing parking lots.

Creating dual right turning lanes on the parkways of both the new development and the Sam's Club / Wal-Mart stores. Cars entering either development would then back-up in the new lanes freeing up space in the existing traffic lanes.

Working in conjunction with residents and BIA to examine the entry points to North Beverly. What impact will this development have at 91st & Western Ave. or 95th & Leavitt? What steps can be taken to protect residents from cut-through traffic.

Working in conjunction with the 95th Street Business Association to explore adding a West bound traffic lane on 95th Street. Such a move would require removing street parking and taking out sections of existing medians. **This change could only occur if adequate off street parking were created to accommodate the businesses that lose street parking.**

These are four ideas that we have asked the authorities to explore. They are by no means a final plan and before any changes move forward there will be ample opportunity for community input. Senator Maloney to Leave General Assembly at End of Term

Senator Ed Maloney recently announced that he will not seek re-election in 2012. Maloney has served as the State Senator in the 18th district since his election in 2002.

Maloney said no single reason is responsible for his choice but a combination of factors contributed. Maloney said surviving colon cancer two years ago, compiled with the fact that successfully winning and serving another four year term would put him at 70 years old, certainly influenced his decision.

"It has been a privilege to serve in the Senate and represent a wonderful constituency. I still love this job and will work at it the last fourteen months of my term as hard as I did the first fourteen months."

"We have always had outstanding public servants from this community including Tom Hynes, Jerry Joyce, Jim Keane, Kevin Joyce and our former Alderman Ginger Ruggai."

Maloney has endorsed State Representative Bill Cunningham for his seat and Aldermanic Aid Fran Hurley to run for Cunn-

ham's spot.

"While I have mixed feelings about leaving, I'm confident that the community leadership under Alderman Matt O'Shea, Cunningham and Hurley will continue to be excellent" said Maloney.



Meanwhile, throughout the Spring and Veto session, Senator Maloney continued to spearhead accountability measures for higher education with the passage of the performance based funding bill.

Community College campuses, many of which now house programs and activities for children, will be a safer environment due to Maloney's sponsorship of the sex offender higher education registration act.

High school students will be better prepared to navigate the college admission process through passage of the college planning act.

An initiative of the Chicago Police Department to crack down on vehicles and drivers used in gun-running was passed by Maloney.

Mount Carmel Students Earning Straight 'A's Honored at School Breakfast

Mount Carmel High School honored a special group of 22 sophomore, junior, and senior students who earned a straight 'A' average during the third trimester of the previous school year with a congratulatory breakfast reception on Thursday.

The academically exceptional students were invited to Mount Carmel's Kiszka Suite where they were addressed by guest speaker Josh Barron, principal of Shepard High School, and congratulated by school leaders, including the school president, Fr. Tony Mazurkiewicz, O.Carm. and the school principal John Stimler.

Barron, a Beverly resident, is a 1992 graduate of Mount Carmel. He spoke about his own career path and the passion for education that was instilled in him at Mount Carmel. 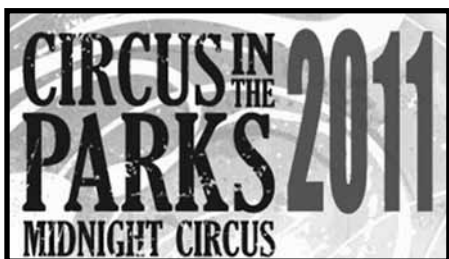

In October, a committee of vol-

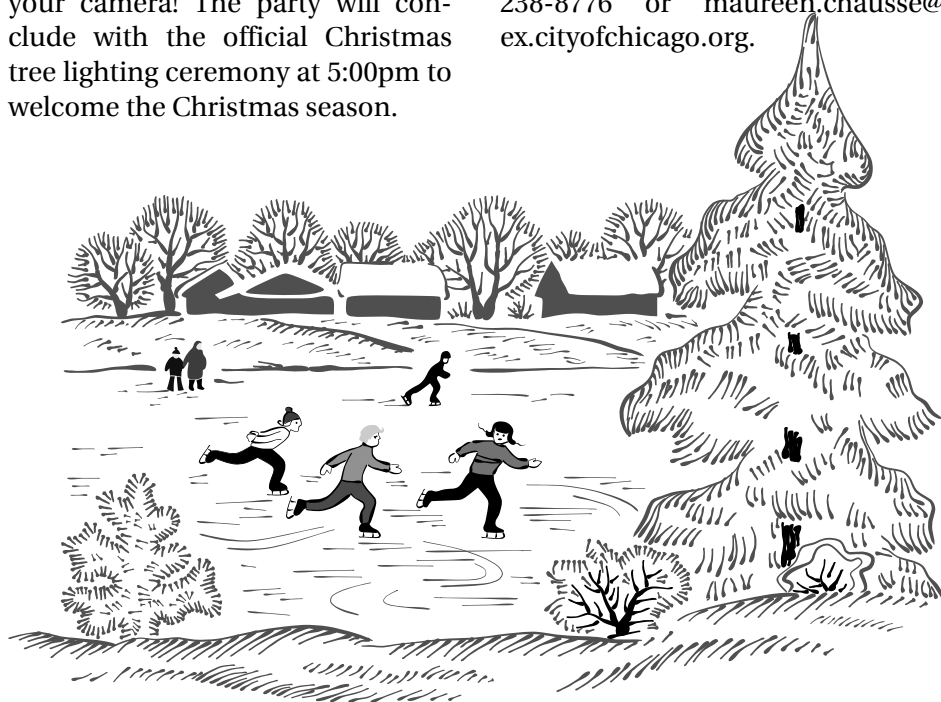

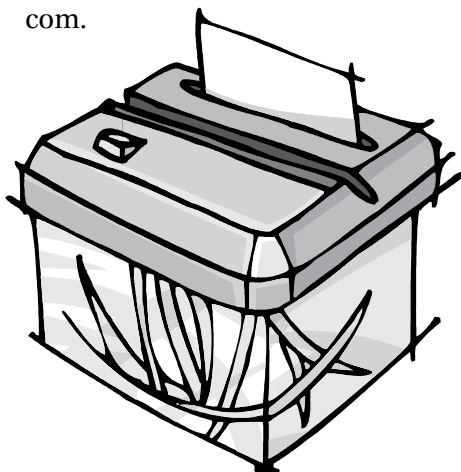


19th Ward to Host Free Shredding Day

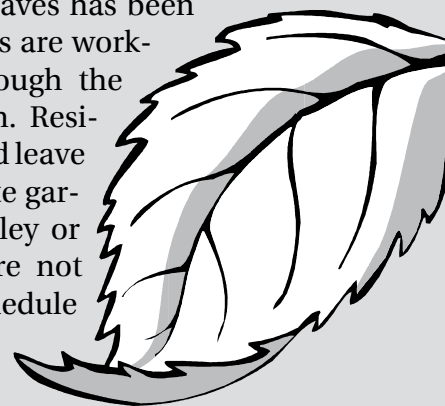
B-Plate Truck Parking Stickers Available

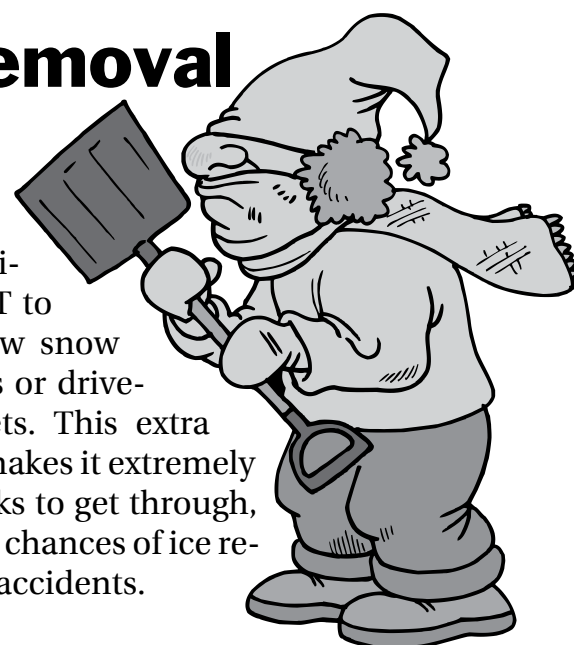
Yard Waste & Leaf Pick Up

Smith Village life enrichment facilitator suggests ways for younger and older generations to connect

"It's unfortunate but many adolescents regard older adults as, 'just that old person,'" says Shelly Genis, life enrichment facilitator and volunteer coordinator at Smith Village, a continuing care retirement community located at 2320 West 113th Place. "When this kind of thinking persists, both younger and older generations miss out on rewarding experiences."

Last year, Genis found a way to overcome the challenge of acquainting younger and older generations. It's an idea that families may want to consider employing during

the upcoming holidays and beyond. "We had so many teens needing community service hours and, of course, several residents who were more than happy to receive volunteer visitors," Genis says. Hence, the Smith Village Write Group was born, a project that spanned several months and included 15 student volunteers.

The students visited residents for one hour each Saturday from November 2010 through May 2011. Genis supplied the students with open-ended questions for the adults, just to get the conversation going. "Later, students were encouraged to get more specific with their own questions," explains Genis.

Some students took notes during their visits and created keepsake journals, which they were encouraged but not required to share. Some added photos, graphics or drawings.

How did the kids like it? "They kept coming back," said Genis. Two students still visit residents and volunteer with additional projects every Saturday morning. Others expressed amazement at the richness of the residents' lives.

How did the residents like it? "They kept asking, 'Are the kids coming?'" Genis says.

"What I also observed is that getting teens talking with adults on a regular basis can help them overcome shyness," she continues. "The two girls who continue to volunteer

occasionally have had to express themselves before groups. You can see they have developed self-con-

fidence."

The magic starts, she adds, with open-ended questions such as:

- *What was the funniest thing you've ever done?*
- *Do you have a hidden talent?*
- *What is the best advice you can give? Has this advice helped you?*
- *What accomplishment are you most proud of?*
- *What is your earliest memory of snow?*
- *How have Christmas celebrations changed since you were growing up?*

Beyond the interviewing and journaling, Genis encourages residents and younger generations to connect through other fun projects.

At Smith Village, student volunteers have helped residents set up email accounts, surf the web, learn how to use Skype, and share photos via the Internet.

In some cases, the older generations have instructed younger ones. Female residents offered students input on the selection of accessories for prom night while sharing stories of proms past. Another resident instructed students on how to crochet strips cut from used plastic shopping bags to create mats for homeless people, to be donated to a community outreach organization in Chicago.

State Representative Cunningham Fights Against ComEd Rate Hike



In the midst of a long national recession, many local residents have lost their jobs and struggled to keep up with rising property taxes. This hasn't stopped the big utility companies from trying to squeeze even more profits from electric customers, putting an even greater strain on family budgets.

Throughout the current legislative session in Springfield, Representative Bill Cunningham has fought back, working to block legislation pushed by ComEd that will make it easier for them to increase electricity rates. Cunningham joined forces with the AARP, Attorney General Lisa Madigan, and other consumer advocates in opposing ComEd's so-called "Smart Grid" bill.

ComEd and the downstate utility Ameren have planned a massive overhaul of the state's electrical grid and have proposed that it be paid for with automatic rate increases over the next ten years. The Smart Grid bill will allow ComEd to avoid annual hearings before the Illinois Commerce Commission for any rate hike requests, which they are required to do under current law.

"No one argues with the fact that improvements to the state's electrical infrastructure are badly needed," Cunningham said. "But I strongly object to the idea that all the costs of updating the electrical grid should be dumped on consumers -- and that's what the Smart Grid legislation does."

Cunningham also objects to granting ComEd a rate hike based on the utilities poor performance in restoring service during storm-related power outages in the 19th Ward in recent years. Several Mount Greenwood, Beverly and Morgan Park residents, restaurants, and other businesses were left without power for extended periods in June and July, costing them thousands of dollars in financial losses due to spoiled food and business closures.

"Utilities are in a unique position because they don't face free

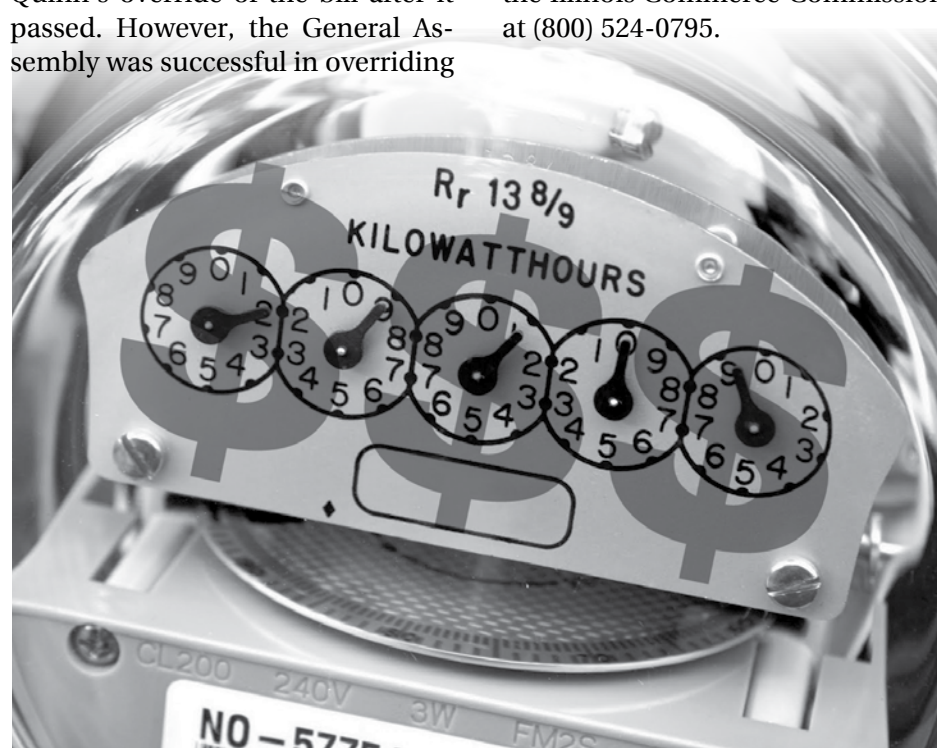
market competition the way other corporations do," Cunningham said. "For that reason, the state needs to hold ComEd's feet to the fire and only grant them rate hikes when they perform well. Clearly, they failed the performance test in our community this summer."

Cunningham was joined by State Senator Ed Maloney and State Representative Kelly Burke in opposing the ComEd bill earlier this year and in supporting Governor Quinn's override of the bill after it passed. However, the General Assembly was successful in overriding

Quinn's veto in October.

"It is unfortunate that the General Assembly ignored the concerns of consumer advocates and allowed the Smart Grid rate hikes to go into effect," Cunningham said. "But our community can continue to hold ComEd and other utilities accountable by contacting the Citizen's Utility Board with any service complaints."

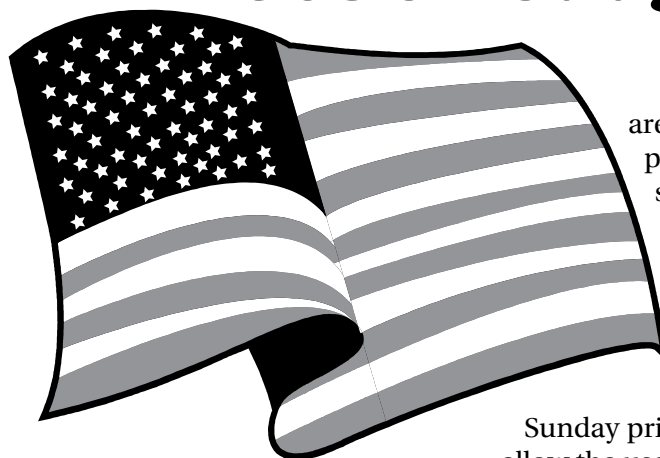
State Representative Burke to host Grant Writing Workshop

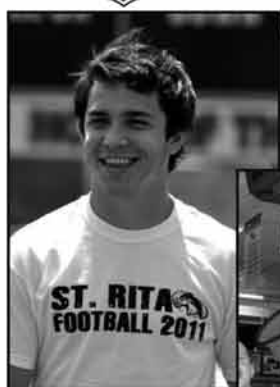

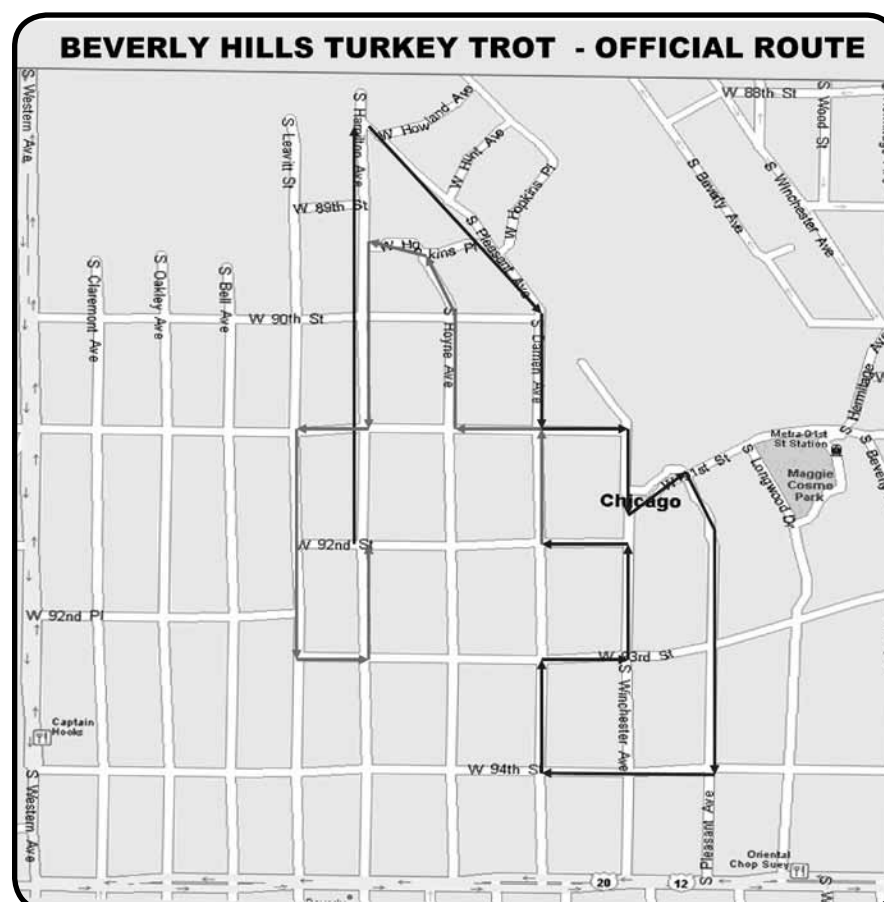
