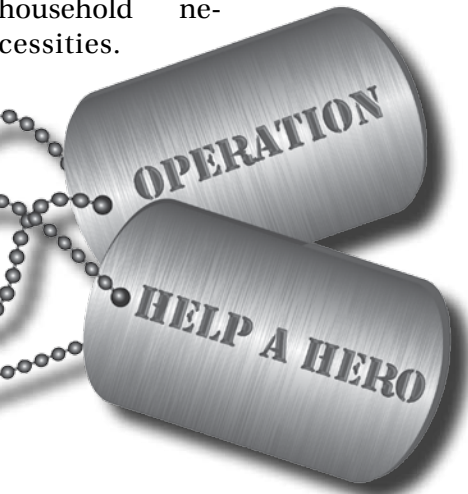


# O'Shea Invited All Chicagoans to Help-A-Hero

Alderman Matt O'Shea, the Chicago Office of Veterans' Affairs, Chicago Park District and Military Outreach USA are hosting a household item collection drive to benefit homeless veterans throughout the month of June. During the past few years, thousands of veterans have transitioned out of homelessness; unfortunately, many of them still lack the most basic household necessities.



Operation Help-A-Hero asks all Chicagoans to consider purchasing one or more of these items to donate to a veteran in need. Donations will be accepted at sixty-five Aldermanic Offices and Chicago Park District locations throughout the City during the month of June. All items collected will be delivered to the United State's Veteran's Affairs Office and distributed to qualifying veterans throughout the Chicagoland area. Local drop off locations include Alderman O'Shea's office at 10400 S. Western Ave., Monday through Friday from 9:00am-5:00pm, and Mount Greenwood Park, 3721 W. 111th St., Monday through Friday from 10:00am-10:00pm, Saturday from 9:00am-2:00pm, and Sunday from 9:00am-5:00pm. Despite recent progress on this issue, there are currently hundreds of homeless veterans who live ei-

ther unsheltered or in shelters throughout the City. "It is our duty as citizens to take care of those who have served and protected our country by getting our veterans back on their feet and successful in private life. It is my hope through this program that we will collect thousands of donations that can help the veterans who have sacrificed so much for our freedom," said Matthew J. O'Shea, 19th Ward Alderman. Operation Help-A-Hero is seeking new, store bought items only. A full list of requested products is below. **PERSONAL HYGIENE:** bath soap, shampoo, conditioner, razors, shaving cream, deodorant, combs, hair brushes, nail clippers, toothpaste, toothbrushes; **KITCHEN & CLEANING ITEMS:** kitchen trash cans (plastic), Windex, Pine Sol, dishwashing liquid,

dishcloths, sponges, mops, buckets, brooms, dustpans, paper towels; **BATHROOM & MISCELLANEOUS ITEMS:** shower curtains, toilet paper (4 or 6 pack), plungers, toilet brushes, toilet bowl cleaner, bath towels (2), wash cloths, smoke detectors w/ batteries, flashlights w/ batteries, garbage bags, laundry baskets, hampers, and laundry detergent. Operation Help A Hero is a 501 (c) (3) public charity dedicated to the well-being and care of our American military members. Their programs support military units and families as they prepare for separation, while they endure the challenges of deployment, and as they transition back to the US. Every cent contributed to Operation Help A Hero is used to serve our military community, and every project is based on real needs.

## City's Battle with CSX Railroad Continues

On February 12, 2016, the City of Chicago and Village of Evergreen Park filed a formal complaint against CSX Transportation with the United States Surface Transportation Board (STB) over the companies operation of the Elsdon rail line, which runs parallel to Sacramento Ave. throughout the 19th Ward. Following that filing, the STB allowed for citizen input on the matter, and received feedback from one hundred twenty area residents. United States Senators Dick Durbin and Mark Kirk, as well as Congressman Dan Lipinski have also submitted letters supporting the City's position.



The complaint alleges CSX has repeatedly violated operating obligations they agreed to follow in 2013 when they first acquired the line. If those obligations were honored, the impact of the railroad on the surrounding community would be significantly lessened. In the petition, the City seeks significant fines, an independent audit of CSX's operations, and possible service restrictions for this line. Despite claims of improved service, CSX's most recent quarterly report documents 22 hours of blockages caused by idling trains alone. The railroad voluntarily agreed to re-open a crossing by cutting a train if a blockage lasts over ten minutes. CSX has largely ignored this commitment for the past three years.

Currently, all filings have been made with the STB and we await their decision. No time frame has been provided for a resolution in this matter.

## Fair Funding Forum at Mt. Greenwood Elementary School

19th Ward Public Schools are hosting a "20 for 20" community forum and rally on Wednesday, May 18, 2016 at Mount Greenwood Elementary School, 10841 S. Homan Ave., at 6:00pm. This event is intended to generate attention and support for the City of Chicago's ongoing efforts for equitable education funding for public schools. Because of annual reductions in funding since 2009, Chicago Public School (CPS) students now receive on average twenty-six percent less in education funding per pupil than children in the rest of the state. Chicago's children are 20 percent of the state's enrollment, and their families and neighbors provide 20 percent of the income tax money that funds public education in our state. However, Chicago's students receive only 15 percent of

the state's spending on education. For every four dollars the state of Illinois provides suburban and downstate districts, it provides just three to Chicago's students. Despite the funding crisis, CPS students continue to thrive. During the past four years, graduation and attendance rates have consistently risen, the composite ACT score is the highest in CPS history, and students outpace their peers nationally in academic growth. Imagine what would happen if the district was funded appropriately? If you would like to show your support for our public school students and teachers, please attend this forum. With your help, we will finally fix our broken school funding formula and strengthen the communities of Beverly, Morgan Park and Mount Greenwood.

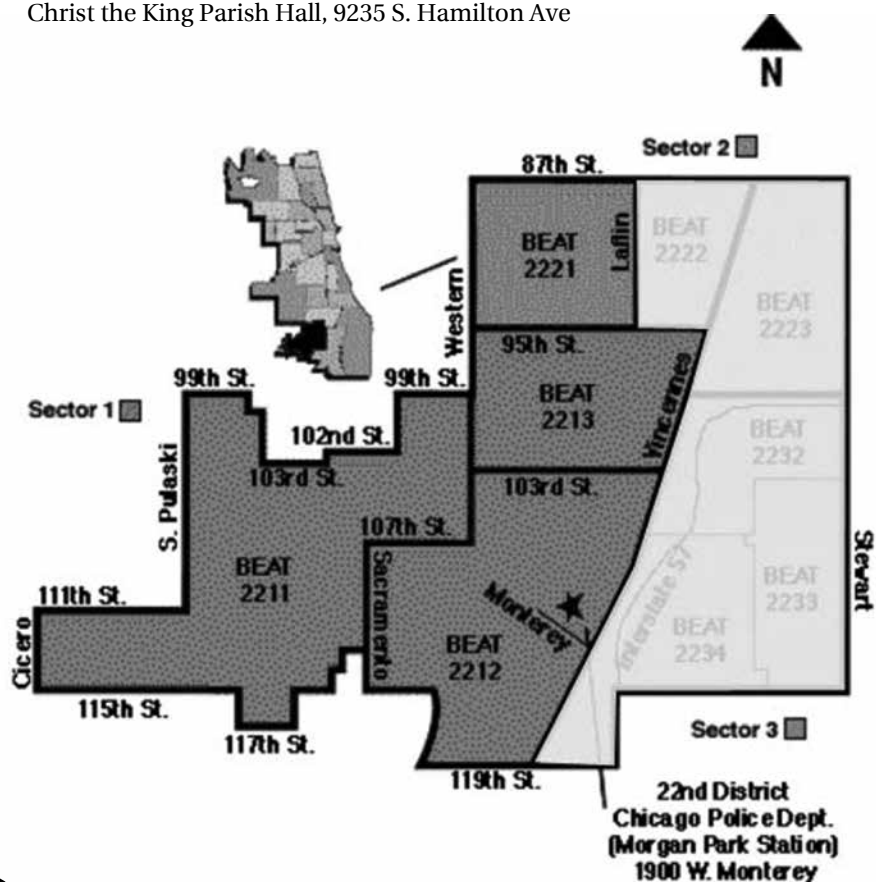

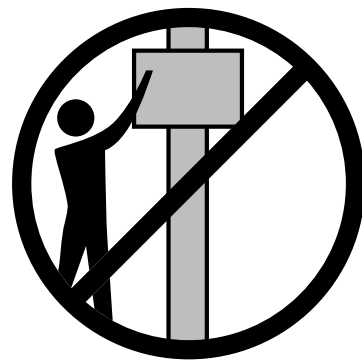
## POSTING SIGNS ON CITY PROPERTY IS ILLEGAL!

As a courtesy to our citizens, the City of Chicago prohibits the posting of signs on any city right-of-way.

This includes posting signs advertising yard sales, lost pets, etc on utility poles and parkways throughout the city.

Please assist us in keeping the 19th Ward the beautiful neighborhood it is by not posting signs on any city right-of-way, parkway or utility pole.



#### 10-8-404 Signs

All signs advising of the occasional sale shall be confined to the premises of which the sale is conducted, and all signs advising of the sale shall be removed no later than 9:00 P.M. on the day the permit expires.

#### 10-8-406 Penalty - Violation

Any person found in violation of any of the provisions of Sections 10-8-401 through 10-8-405 shall be fined not less than \$50.00 nor more than \$500.00 for each offense, and each day such violation persists shall constitute a separate and distinct offense.

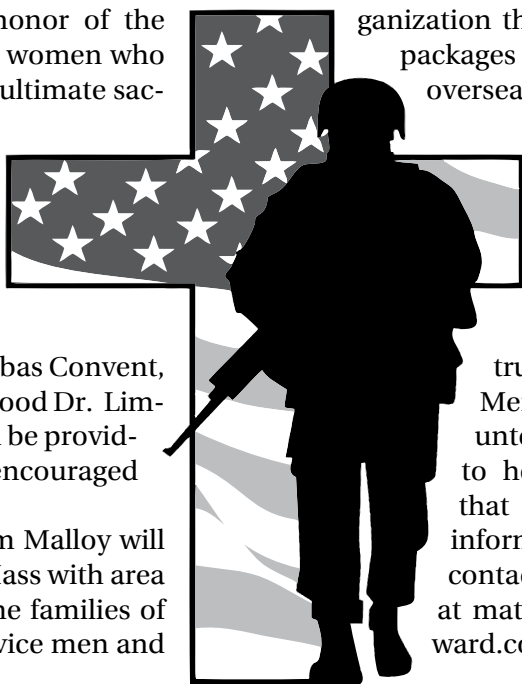
# Mass Planned to Honor Veteran's and Active Servicemen

## Chicago Smart Lighting Project

The Chicago Infrastructure Trust (CIT), in coordination with the City of Chicago and the Chicago Park District, has launched a major initiative to upgrade more than 270,000 of the city's street, alley and park lights to more reliable and higher-quality lighting.

The Chicago Smart Lighting Project seeks to improve safety and quality-of-life

in neighborhoods across Chicago by replacing nearly all of the city's outdated and inefficient High Pressure Sodium (HPS) lamps. Additionally, the project anticipates improving the City's responsiveness to outages with a lighting control network that will provide real-time

updates when outages occur.

The project will be one of the largest municipal lighting modernization programs in the country. A request for qualifications/proposals has been issued to begin the procurement process; a copy of that document is available online

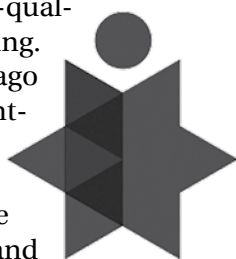

Smart Lighting is anticipated to be a significant investment in the City's infrastructure that will create jobs for Chicagoans.

The RFQ phase of the procurement will short-list teams who will be asked to respond to the RFP; work is expected to begin in 2017 and last approximately four years.



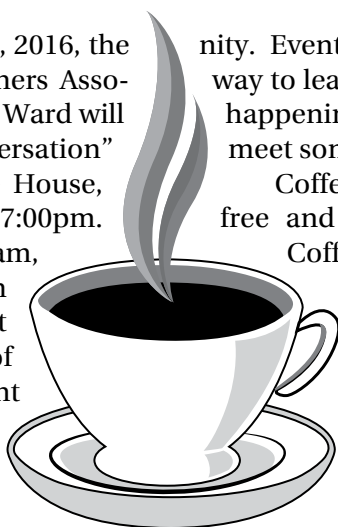
## Coffee & Conversation on June 28th

Last year one fourth of all customers skipped the lines and obtained their stickers through the Clerk's website. This is the easiest and fastest way to receive your vehicle sticker each year. However, if you prefer to purchase your sticker in person, Alderman Matt O'Shea and City Clerk Susana Mendoza will host sales on Thursday, May 26th from 12:00pm-4:00pm at Ridge Park, 9625 S. Longwood Dr., and Thursday, June 23rd from 12:00pm-4:00pm at the 19th Ward's Mt. Greenwood Service Office, 3215 W. 111th St.

To purchase a vehicle sticker, you must bring your 2015 Chicago City Vehicle Sticker courtesy reminder form. If your courtesy reminder is lost, please bring your State Vehicle Registration ID Card, which includes your VIN (Vehicle Identification Number). Check, money order, Visa, MasterCard, Amex and Discover Card are accepted at Ward Sales. Please remember, we are now in the Year Round Vehicle Sticker era. Ward Sales this year will be limited to customers with June vehicle sticker expirations. These are vehicle stickers with "6/16" printed on them with an expiration date of June 30.

## Cook County Assessor Property Tax Appeals

The Cook County Assessor property tax appeal process for Lake Township, which includes the 19th Ward, opened May 11, 2016 and will be open for thirty days. This is the first opportunity to appeal 2016 taxes. The other option is the Board of Review appeal, which opens in fall. It can be beneficial to file appeals with both agencies. Common reasons to file an appeal

with the Assessor are lack of uniformity with similar within the same neighborhood code, overvaluation based on recent sales and significant property description errors. This appeal process is for 2016 property taxes which are due in 2017. Appeals can be made in person at any Cook County Assessor office, online at [www.cookcountyassessor.com](http://www.cookcountyassessor.com) or appeal forms are available at both 19th Ward offices.

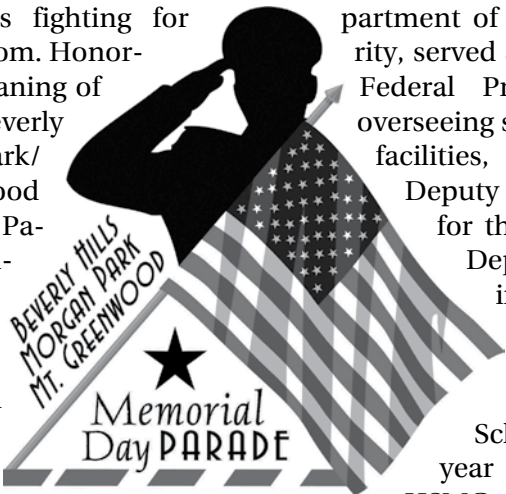

# Honoring Our Heroes: Memorial Day Parade

Memorial Day is dedicated to remembering the men and women of the U.S. Armed Forces who gave their lives fighting for America’s freedom. Honoring the true meaning of the day, the Beverly Hills/Morgan Park/Mount Greenwood Memorial Day Parade will follow the Ridge Run, stepping off from 110th and Longwood Drive. Participants and spectators are encouraged to join BAPA, Parade participants, community leaders and families for the laying of the wreath, color guard and Memorial Day ceremony.

Grand Marshal of the parade is Gary W. Schenkel, a retired United States Marine Corps Lieutenant Colonel and Executive Director of the Chicago Office of Emergency Management and Communications (OEMC). In his career in public service, Schenkel has served at the most senior level in the Department of Defense, the Chicago Police Department (CPD) and in Federal law enforcement.



Prior to becoming Director of OEMC, Schenkel served as Acting Assistant Secretary for the Department of Homeland Security, served as Director of the Federal Protective Service overseeing security in federal facilities, and was Acting Deputy Superintendent for the Chicago Police Department, leading anti-terrorism efforts following the attacks of Sept. 11, 2001. Schenkel is a 29-year veteran of the USMC, serving both enlisted and office grades. He retired in 2000.

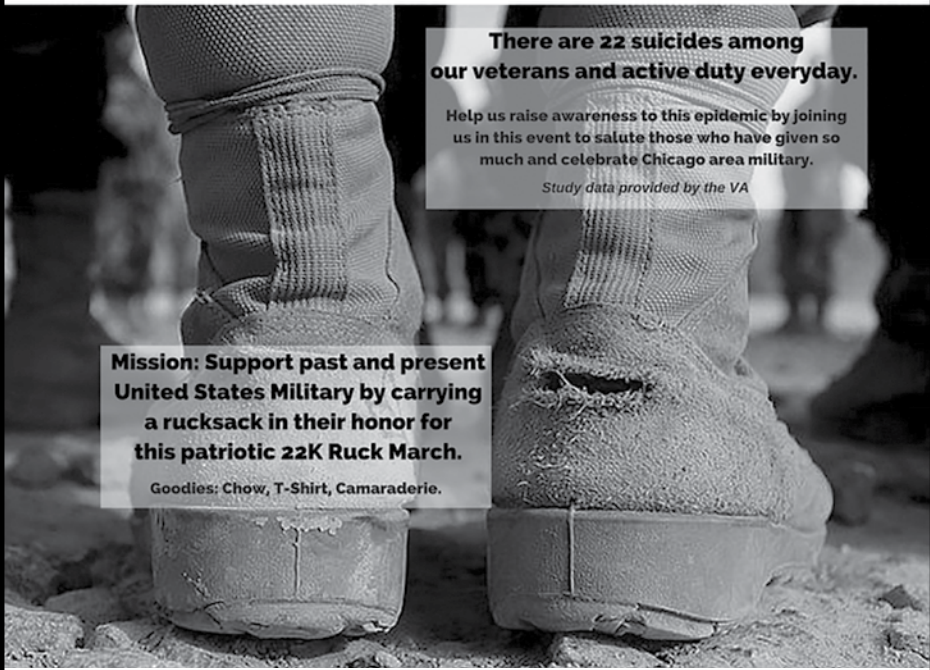

A group of Morgan Park High School students will interview Ms. Zopp at an assembly for all Junior and Senior class members; immediately following the interview, Zopp will take questions from individual students. An accomplished attorney and non-profit executive, Andrea Zopp was born in Rochester, New York on January 25, 1957 to Reuben K. Davis, a prominent lawyer and judge, and Pearl Greta Davis, a human resources professional. As a child, Zopp was taught the values of education, service and hard work. Zopp completed her B.S. degree

in history and science at Harvard University in 1978 and received a J.D. degree from Harvard Law School in 1981. After being licensed to practice law, Zopp worked as a law clerk for U.S. District Judge George N. Leighton.

In 1992, Zopp became the first woman and first African American appointed as a Cook County First Assistant State's Attorney where she prosecuted several high profile cases. From 2000 to 2003, Zopp served as executive vice president and general counsel at the Sara Lee Corporation and as president from 2003 to 2004, general counsel of Sears Roebuck and Company. Zopp then worked as adjunct professor at several law schools including Northwest-

ern University and Harvard Law School. In 2006, Zopp was made head of Exelon Energy Corporation's human resources division.

She was promoted to executive vice president and general counsel of Exelon in 2009. Zopp left Exelon in 2010 to become president and CEO of the Chicago Urban League. Earlier this month, she was appointed Deputy Mayor of the City of Chicago by Mayor Rahm Emanuel.

Zopp has served on many boards of directors for many organizations including Chicago Area Project, Leadership Greater Chicago, Harvard Alumni Association, National Urban League, Black Ensemble Theater and the Cook County Health and Hospitals Sys-

tems. She is a member of the Black Women Lawyer's Association, Delta Sigma Theta Sorority, Inc., The Chicago Network, and The Economic Club. Zopp has served on commissions for the Review the Illinois Death Penalty Process and chair of the blue ribbon commission for Magnet and Selective Enrollment School Admissions for the Chicago Public Schools. Zopp is married to William Zopp and they have three adult children Alyssa, Kelsey, and Will.

## City Services Update

### STREET SWEEPING

Chicago's street sweeping season began **April 1 and runs through mid-November**. If a street is scheduled for sweeping, a temporary no parking sign will be posted along the route the day before service to ensure curb-to-curb cleaning. Some arterial streets may already have permanently posted signs that specify a once-per-week period when parking is prohibited due to sweeping. Residents who need more than one day notice of street sweeping should contact their local ward sanitation office. The 2016 street sweeping schedule is available at [www.cityofchicago.org/dss](http://www.cityofchicago.org/dss).

### YARD WASTE COLLECTION

The City is coordinating dedicated yard waste collection trucks this spring to assist residents in clearing their yards, parkways and storm drains following the winter season. Residents can call 311 to request separate yard waste collection from **April 16 through April 22**. Yard waste should be left in the alley or at the curb for collection, and bagged separately from garbage in the black carts and separately from recycling in the blue carts. A Streets and Sanitation truck will collect the bags based on 311 requests and take it to be composted.

# City Cracks Down on Beverly Hills Food Mart

In response to residents’ complaints, the City of Chicago conducted an investigation at Beverly Hills Food Mart (2156 W. 95th St.) on April 28, 2016. Inspectors found several instances of outdated merchandise mixed with non-outdated merchandise and issued six citations. A hearing will be held on this matter on May 24, 2016 at 10:00am at 400 W. Superior, Room 107. All interested parties are welcome to attend.

## Blue Cart Reminder Reduce, Reuse, Recycle

The 19th Ward was one of the first wards chosen for the blue cart recycling back when it was still a pilot program. Our ward has even had some of the higher participation rates over the years since the pilot days and through the full citywide roll-out. While this is encouraging news for our neighborhood, we could improve those numbers as overall recycling participation for the City as a whole has dipped slightly. In 2015, recyclable materials equaled 10.23% of total collected refuse; down from 11.08% in 2014, and 12.21% in 2013. Let’s help to reverse this trend!

Chicago has what is referred to as single stream recycling, where all the recyclable materials go in one cart and are sorted at a collection facility later. With the implementation of new rules that began in January of this year, perhaps it is time for a refresher of what is allowed in the blue carts and what is not. Some ward residents might have received or noticed orange “reject” stickers on blue carts, these stickers indicate something in the cart violates the new regs – especially if they contain items in plastic bags. If the recycling crew spots any trash in a bin, they’ll re-route the whole thing to garbage collection instead of the recycling sorting center. **One of the biggest changes as of this year is the materials need to be loose and unbagged.**

The City of Chicago website has a more definitive list of what is and is not allowed, however, here are some **tips to remember:**

- Go bagless: items need to be loose in the cart to ensure an easier sorting process. Paper bags can be recycled but need to be emptied.
- All glass and plastic bottles, all aluminum and steel cans, all cardboard cartons (milk, soup, broth, juice, etc) are allowed
- No glass other than bottles (no lightbulbs, dishes, stemware)
- All magazines, office paper, envelopes (even the ones with the clear window), newspapers
- Items do not need to be scrubbed spotless
- BUT no greasy or dirty containers with food residue (no paper napkins, no pizza boxes), it needs to go in the black trash cart, not the blue as the residue has saturated the cardboard
- No styrofoam of any kind, perhaps try to reduce usage
- No plastic shopping bags – perhaps try to reduce usage, and if you do have these, many grocery stores and Walgreens/CVS have bins where you can drop them off
- No polystyrene/foam #6, as in no disposable cups! This includes the red Solo cup, clear plastic to-go cups, coated cups from coffee shops
- No electronics, cords, pots or pans

# O’Shea Opposes Strip Club Ordinance

Dear Neighbors:

Last month, the Chicago City Council considered an ordinance that would permit the sale of alcohol in adult entertainment venues that feature live, fully nude entertainment. Currently, strip club owners must choose between offering alcohol with partial nudity, or full nudity without alcohol. As this measure advanced through the legislative process, I found myself asking why such a change was necessary, and more importantly whom it would benefit?

According to the National Human Trafficking Resource Center, strip clubs have become a hub for human trafficking and the exploitation of women. Moreover, a Center for Impact Research study on women involved in the sex trade in Chicago found that exotic dancers are subjected to “a great deal of violence, including being threatened with a weapon or threatened with rape.” We should not respond to such problems by relaxing the few restrictions currently placed on these businesses. And no matter the amount, the proposed ordinance’s financial incentives for domestic violence and sexual assault programs cannot offset its contribution to the root problems these programs exist to address.

Is the adult entertainment industry in Chicago failing and therefore in need of this intervention to remain competitive? There is certainly no evidence to suggest this is the case; during the last sixteen years, not one Chicago legal strip club has gone out of business.

During my five years in the City Council, I have worked with and supported organizations that seek to stem the tide of sexual violence in our city. The passage of this ordinance would have been a huge step backwards. Thankfully, this ordinance has not yet been called for a vote. Should that change, I hope that all Chicagoans can stand together in opposition to this policy blunder.

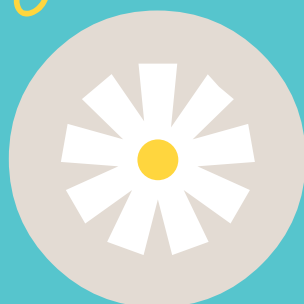

All equipment has been ordered and installation will occur this summer. This \$50,000 project was partially funded through a grant from Greenfields Outdoor

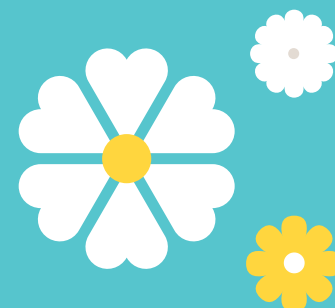

## Chicago Seeks Election Judges

The Chicago Board of Elections is currently recruiting judges of election for the November 8, 2016 Presidential Election. Election Judges are the officials responsible for administering the election in each polling place. The judges of election are the backbone of the electoral process.

On Election Day, every precinct has a team of judges that is responsible for setting up voting equipment at 5:00 am, conducting a fair, impartial and secure election, allowing voting from 6:00 am to 7:00 pm, and tabulating the vote totals and transmitting them to the Board of Elections after the polls close. Judges of election are paid \$170 upon completion of training and service on Election Day. Ex-

tra compensation is paid to judges who pick up the key envelope on either the Saturday or Sunday prior to Election Day, allow the use of their cell phone by all judges within the polling place on Election Day, or return the election materials to a receiving station on Election Night, or serve additional days in absentee voting, nursing-home voting or in post-election counting activities in the warehouse.

Please note, to serve as an Election Judge, you must be a registered voter in Cook County, and be able to speak, read and write English and perform basic math. # Legislative Update

## How Illinois’ education funding policies affect Chicago Public Schools

The Chicago Public School System is facing a severe financial crisis. As a result, many are looking to Springfield – either to assign blame or ask for a solution.

And the truth is, policymakers in Springfield deserve most, (but not all,) of the blame for the current CPS financial problems. In 1995, the General Assembly passed and Governor Edgar signed the Chicago School Reform Amendatory Act. By almost any measurement, it has proven to be an unmitigated disaster. The current structural and financial problems at CPS were almost all caused by provisions of the 1995 Act.

That “reform” plan weakened the influence of Local School Councils and gave complete control of the School Board and central administration to the mayor. Independent, community-based school board members were replaced by mayoral appointees, most of whom

came from corporate and banking backgrounds. In the two decades since, pliant school boards have approved a succession of bank-favoring borrowing schemes and no-bid consulting contracts. Each passed with few questions and even fewer dissenting votes.

Worst of all, the 1995 Act is almost solely responsible for creating the CPS pension crisis. It eliminated a law that required CPS to dedicate a portion of its tax levy to directly fund the Chicago teachers retirement system, which was in solid financial shape at the time. The school board was freed to spend those tax dollars anyway they wanted. And if that wasn’t bad enough, the 1995 Act explicitly authorized the school board to skip future pension payments. Today, the nearly half-billion dollar hole in CPS’s budget can be almost entirely blamed on pension debt created by these policy changes.

The dedicated pension levy that was eliminated in 1995 was important because it helped keep

the teachers pension fund solvent despite a quirk in Illinois state law that is unfair to Chicagoans. As long as anyone can remember, the state has paid the regular employer pension costs for teachers in all suburban and downstate school districts, but not for Chicago teachers. Last year, the state spent about \$7.5 billion on teacher pensions, almost all of it for suburban and downstate schools, and next to nothing for Chicago.

There are a handful of proposals pending in Springfield that could help solve these financial problems. One is House Bill 3695, which would force CPS to once again automatically dedicate a portion of its property tax levy to the teachers pension fund. Additionally, legislation has been proposed to change the state’s complicated school funding formula, like Senate Bill 231. This plan would funnel more state financial aid to districts, like Chicago, that have a high number of student who live in poverty, speak English as a second lan-



guage, or have special education needs.

In an effort to promote possible solutions to the problem, the CPS administration is busy promoting a campaign they call “20 for 20.” Currently, CPS students make up 20 percent of Illinois’ total number of school children, but CPS only receives about 15 percent of state school funding. This disparity is almost entirely attributable to the state picking up all pension costs for every school district in the state except Chicago. The “20 for 20” campaign is seeking to bring Chicago equity in school funding.

## Legislative Update from Rep. Kelly Burke



### HIGHER EDUCATION STOPGAP FUNDING BILL SIGNED INTO LAW

Millions of dollars in promised state financial aid for college students will finally arrive under a sweeping, bipartisan budget deal approved late last week by lawmakers and signed by the governor. The deal - essentially a fiscal stopgap for students and universities teetering on crisis for nearly a year - approves spending on the state’s Monetary Award Program for college students and starts sending state dollars to public universities and community colleges, some of which were on the verge of shutting down.

While this funding is welcome and much needed, Rep. Burke recognizes the legislation is a short-term solution and a broader budget fix is needed. Students and university employees want real answers and long-term stability rather than the chaos that’s been created the past year. They want the state to start solving problems rather than creating problems.

### REP. BURKE SUPPORTS PROPERTY TAX FREEZE BILL

Last week the House passed HB696, which would freeze tax levies for all non-home rule units of government. Under the bill’s provisions, these units of government would generally need to take increases in their tax levy to the voters through a referendum. The property tax freeze issue has been before the House many times before and Rep. Burke has consistently supported the bills. HB696, however, is the first bill to pass, earning the “yes” votes of a bipartisan group of lawmakers.

### REDISTRICTING AMMENDMENT CO-SPONSORED BY REP. BURKE

HJRCA58 would change the way that legislative and congressional maps are drawn after each census. The task would be turned over to a redistricting commission rather than the current arrangement in which the legislature draws the maps. If HJRCA58 passes both chambers of the legislature, the proposal would be a question on the ballot in November, giving Illinois voters the chance to weigh in.

## Hurley Pushes for Fair Education Funding

Among Illinois’ most important responsibilities is ensuring every student in the state has access to a first class education. What students learn now, in grade school through high school, is pivotal to their ability to be successful when they move on to college or the workforce. Currently I’m supporting a proposed constitutional amendment that would change education from a goal to a right, and would require the state to take greater responsibility for financing public schools.

If we want our kids to be ready to solve tomorrow’s problems across Illinois, we have to make the right kind of investments in their future now. Last year, I supported a budget that increased money to schools across Illinois, House Bill 3763, which increased funding for education across the state by \$244 million. I’m pushing to increase this investment now for next fiscal year. This is the only way our students will have access to the 21st century education they deserve.

Illinois is in the midst of an unprecedented budget impasse. However, ensuring that students in every corner of the state don’t become victims of Springfield’s problems remains among my highest priorities. Many school districts in Illinois don’t have access to the kind local property tax revenues it will take to keep them afloat, and the possibility of schools not being able to open their doors on time is a very real possibility. This result is unacceptable and all state leaders should agree that we have a responsibility not to let that happen.

Politicians in Springfield and in Chicago have failed our kids and their schools for too long, and that’s why I’m supporting efforts to create an elected school board in Chicago to provide more transparency and community input into the governing of our schools and ensure they get the resources they need.

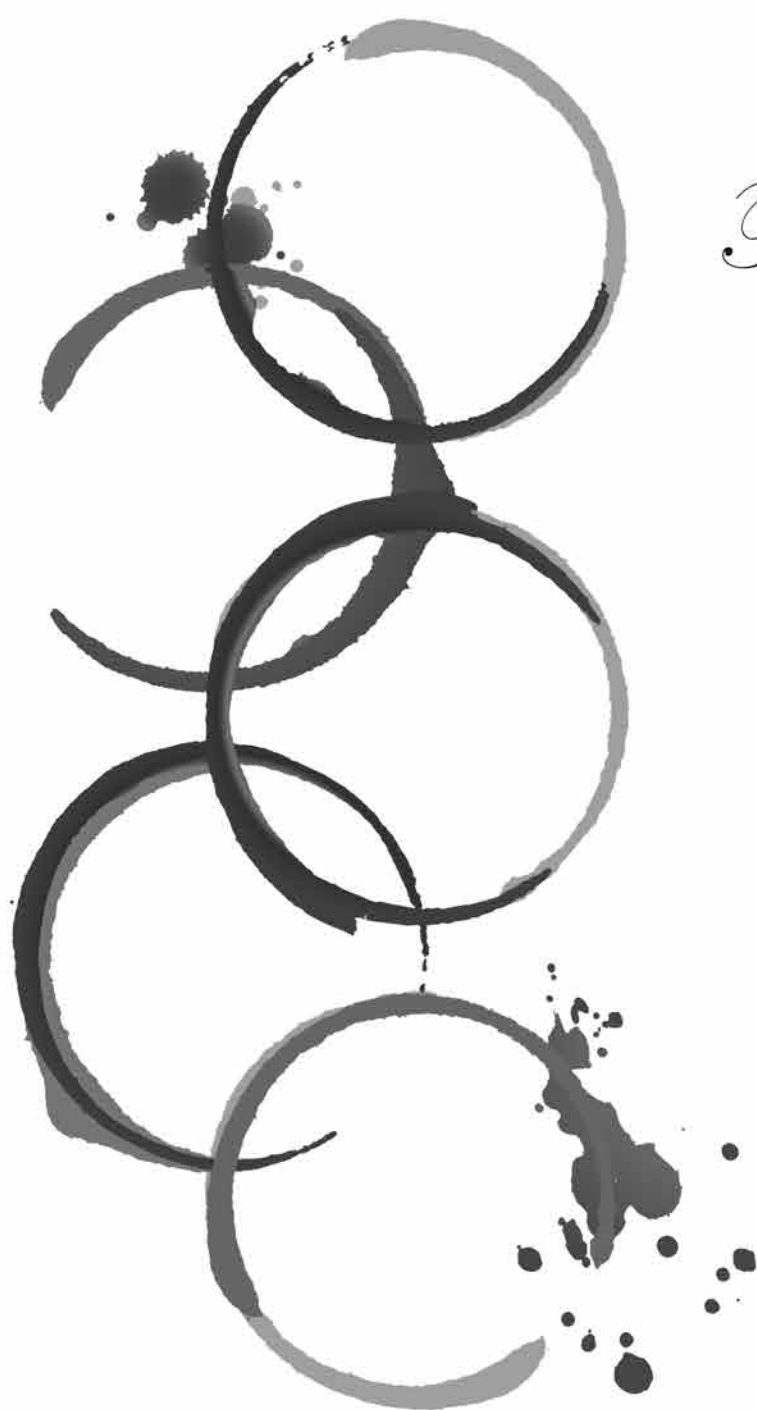
