World Trade Center Steel
Coming to King Lockhart Park

A sculpture forged from a steel beam from the World Trade Center will be installed at King Lockhart Park. The beam, a gift from the New York City Fire Department, was presented to the Chicago Fire Department in 2013 to recognize the many Chicago first responders who travelled to ground zero in the aftermath of the 9/11 terrorist attacks. Alderman Matt O'Shea is working closely with the Chicago Fire Department, Chicago Park District, and the family of Captain Herbie Johnson to bring this important public art work to our community.

Captain Johnson, who died

in the line of duty on November 2, 2012, was among those who organized groups of firefighters to travel to New York. A second,

smaller piece of steel was presented to the Johnson family and is currently on display at his fire house. Chicago artist Terence Karpowicz will create the sculpture; currently he is developing some concepts for the project and finalizing the budget.

New Playgrounds Planned for
Beverly and Munroe Parks

Mayor Rahm Emanuel, Alderman Matt O'Shea, and the Chicago Park District have finalized plans to replace the playground at Beverly Park. The project will include a new, more durable, poured in place soft surface. It will also feature play equipment for children

of all ages including two slides, swings, and several climbing nets. Construction is expected to begin next Spring and complete in late Summer 2018.

Alderman O'Shea is also working with Mayor Emanuel, Senator Bill Cunningham, State Rep. Fran Hurley, and the Chicago Park District to secure funding to replace the playground at Munroe Park. That project is currently in development and is expected to break ground in late 2018. More information and renderings will be shared with the community in the coming months.

Public Safety Update

Dear Neighbor,

Last night, the Beverly Area Planning Association, Chicago Police Department and I hosted a public meeting to discuss safety in our community. Based on feedback from that meeting, the Chicago Police Department - Area South will begin issuing alerts on single incident gun related crimes in the 22nd District. My office will continue to distribute via email the alerts we receive from the Chicago Police Department.


Historically, Area South has issued community alerts when crime patterns are identified. However, given the heightened concerns associated with recent gun related crimes, all parties agree to work more closely together. In addition, the Chicago Police Department has also deployed additional resources to our community in response to the most recent series of incidents.

Also, some residents expressed confusion and frustration with the 9-1-1 process. In response, I have invited representatives from the Office of Emergency Management and Communication (OEMC) to attend the upcoming

CAPS meeting for Beats 2211 and 2212, which will be held on Thursday, December 7th, 7:00pm at the 22nd District Police Station, 1900 W. Monterey Ave. All residents who have concerns or questions about 9-1-1 are encouraged to attend.

I would like to thank all of the residents who attended yesterday's meeting, and the Beverly Area Planning Association for their partnership on safety matters. I'd also like to thank the Chicago Police Department for their responsiveness to our community and for their ongoing efforts to maintain public safety. Working together, we will keep our neighborhood strong and safe for the future.

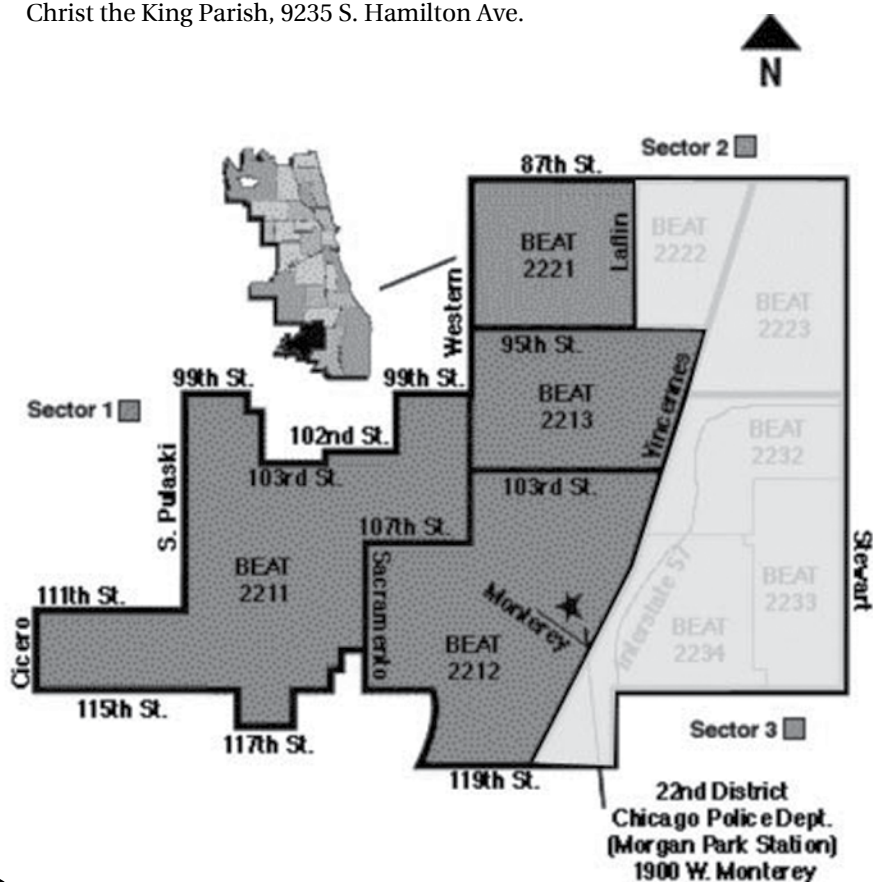

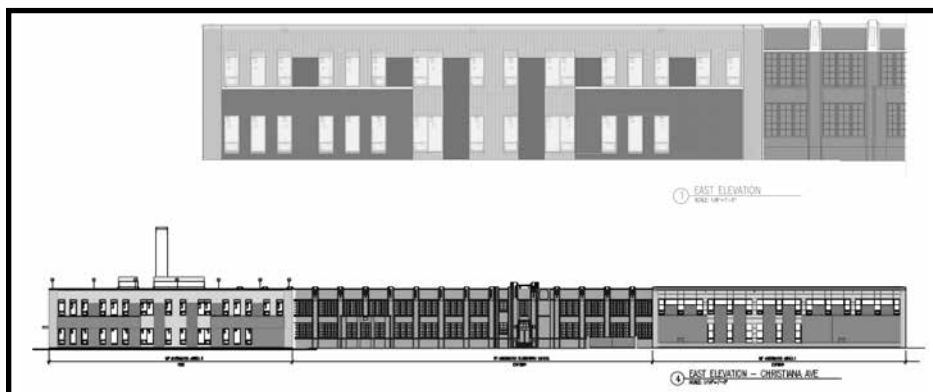

CPS Begins Work at Mount Greenwood & Esmond

Earlier this year, Mayor Rahm Emanuel and Alderman Matt O'Shea announced a forty million dollar investment at Mount Greenwood and Esmond Elementary Schools. Site preparation is currently underway at both locations. Any resident interested in working on one of these sites is invited to a community hiring fair on Thursday, December 7, 2017 from 10:00am-

2:00pm at the Beverly Art Center, 2407 W. 111th St.

An overview of both projects, provided by the Public Building Commission of Chicago (PBC), can be found below. The PBC expects the annexes to be completed in January of 2019.



Mount Greenwood Elementary School Annex & Renovations:

A new, two-story annex to the existing two-story school will be constructed to alleviate overcrowding. The annex will include thirteen standard classrooms, one science room, two offices, storage, bathrooms, utility rooms, an elevator and building support space. The project will also include a new parking lot, storm water management infrastructure, and a new outdoor playground. Work within the school building will include the conversion of two existing classrooms for expanded lunchroom capacity.

Site preparation and utility work has been completed for this project. Contractors are currently working on the foundation for the new annex; that phase of construction is scheduled for completion in January 2018. The construction contract is currently in the procurement process. The PBC expects that contract to be awarded in the coming weeks.

Esmond Elementary School Annex & Renovations:

A new, two-story annex to the existing two-story school will replace a deteriorating stand-alone modular building. The annex will include a classroom, computer classroom, science classroom, art room with storage, library, dining room, hybrid kitchen and server, administrative office, bathrooms, building storage, an elevator and building support space. The project will also include renovated parking lots, load area, refuse enclosure, storm water management infrastructure, a new outdoor playground, community garden, and a turf field.

Site preparation and utility work has been completed for this project. The construction contract is currently in the procurement process. The PBC expects a contract to be awarded in December of 2017.

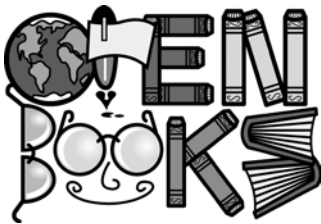




Used Children’s Book Drive

City Announces Benefits for Employees Living with Domestic Violence

In recognition of Domestic Violence Awareness Month, Mayor Rahm Emanuel and Alderman Matthew O'Shea introduced an ordinance that reaffirms the City of Chicago's commitment to protecting and supporting its employees who are survivors of domestic violence and sexual assault. Additionally, the city will also provide up to one month of paid leave for City employees who qualify for the Victims' Economic Security and Safety Act ("VESSA"). An Illinois state law, VESSA requires employers to provide survivors of domestic violence and sexual assault with three months of unpaid leave.

"Domestic violence and sexual assault have no place in our society and it is critical that survivors know they are not alone," Mayor Emanuel said. "We recognize the challenges survivors face and believe this ordinance is a significant step in expanding our support and reaffirming the City's continued commitment to providing accessible resources for those affected."

Under the ordinance, the Commissioner of the Department of Human Resources is charged to develop a policy and implement training to improve employees' awareness of existing resources, their ability to recognize warning signs of abuse and act responsively in furtherance of this goal.

"Our goal is to ensure that City employees affected by domestic violence and sexual abuse know that they have their employer's support through accessible information,

resources and employee assistance programs," Alderman O'Shea said.

The ordinance was developed in coordination with Chicago Says No More, a coalition of 20 business, civic and philanthropic leaders collaborating with 25 executive directors of not-for-profit organizations with a mission to serve those affected by domestic violence and sexual assault. Their Workplace EAP Task Force collaborated with Legal Momentum, the nation's oldest legal advocacy organization dedicated to advancing the rights of women and girls, to create a model policy for employers. Legal Momentum was instrumental in drafting and helping pass the Violence Against Women Act, the landmark federal law created to address the treatment of the crimes associated with domestic violence, sexual assault and stalking. Information about the model policy is available at www.ChicagoSaysNoMore.org.

"Domestic violence and sexual assault are difficult topics to breach, and because of longstanding stigmas, victims and survivors are often reluctant to seek help at a time when they are extremely vulnerable and likely very isolated," said Kristie Paskvan, CFO of Mesirow Financial and founder of Chicago Says No More. "The new ordinance works to help ensure that the City's workplace is a safe environment for all employees who are experiencing abuse and creates a means to provide immediate assistance to employees who have been subjected to such violence."

The City of Chicago currently offers a number of services and resources to domestic violence survivors. DHR employs a clinical therapist who is able to provide confidential consultation and assistance, offers a residency waiver if an employee needs to quickly relocate and provides reasonable accommodations such as changing work phone numbers or modifying a work schedule or location.

"The case with many employees is that they offer numerous services, but the information about them is scattered, so employees have to conduct their own research and, as a result, may not know about everything that is available," DHR Commissioner Soo Choi said. "An easily accessible document centralizing this information, together with training to increase awareness, ensures that our employees can easily access that assistance and know that we support

them and encourage them to seek our help."

According to the Center for Disease Control, one in three women and one in four men are victims of domestic violence. Domestic violence can co-occur in the forms of physical abuse, psychological abuse, economic abuse and stalking. It is the leading cause of injury to women between the ages of 15 and 44 in the United States, more than car accidents, muggings, and sexual assault combined. Unfortunately, only 14 percent of employers offer assistance for those employees affected by domestic violence and sexual assault when the abuser is not a co-worker.

Jason Hicks Arrested for 95th Street Shooting

The Cook County State's Attorney's Office has charged Jason Hicks, the man believed to be responsible for the October 12th shooting incident that occurred on the 2100 block of west 95th Street, with unlawful use of a firearm, a class three felony. The Chicago Police Department's Fugitive Apprehension Unit arrested Hicks on the 5500 block of south Lake Park Ave. on Thursday, November 2nd. Hicks, a convicted felon currently out on parole, was in possession of a loaded pistol at the time of his arrest.

Moving forward, the 19th Ward will continue to work closely with the Chicago Police Department and Cook County State's Attorney's Office to ensure an aggressive prosecution of this case.

It is important to note that this incident was not a random act of violence. Law enforcement authorities believe this is related to a domestic dispute between Hicks, the victim, and a woman.

Several local businesses provided assistance, including video footage of this incident, to the police. Their cooperation remains vital to this case and our entire community thanks them. Working together, we can maintain a safe and healthy community for our families. We will keep you updated on this matter as more information becomes available.

Legislative Update

Hurley Pushing for Expanded Protections for Police and Fire Fighters

State Representative Hurley is continuing the discussion on how to protect first responders statewide and ensure structurally dangerous buildings are clearly marked. Hurley introduced HB 3148 earlier this year which requires local governments to post a notice on structurally damaged or unsafe buildings. Buildings that pose a potential risk to police or fire fighters responding to an emergency would be identified with a large, noticeable marking such as the red “X”.

Buildings with a red X have structural damage to the degree that it would be dangerous to enter. This measure aims to keep first re-

sponders safe when responding to an emergency. The bill idea originated from a conversation Hurley had with a constituent while walking door-to-door in her district.

“Our first responders deserve to know when a building they’re about to enter has major structural problems,” said Hurley. “By marking these buildings with a red X or something similar, first responders can act accordingly in an emergency to keep themselves and their colleagues safe.”

Despite the intent of the bill, it has been met with some reluctance because of concerns with a term used in the bill that is not included

in the International Property Maintenance Code. Hurley discussed her bill in front of the House Construction Industry and Code Enforcement Committee, where testimony was heard from the Illinois Fire Fighters Association, City of Chicago Illinois Fire Inspectors Association, and City of Chicago Department of Buildings.

Hurley will continue to work with stakeholders and push for critical protections for police and fire fighters. Passage of HB 3148 would provide an increase in safety for first responders throughout Illinois.

Cunningham Proposes Identity Theft Protection Measure

Illinois residents wishing to protect their identity by signing up for a credit freeze will no longer have to pay a fee to do so under legislation introduced by Senator Bill Cunningham in the Illinois Senate.

The new effort to protect consumers has been launched in reaction to the massive data breach suffered by the credit reporting giant Equifax earlier this year. As many as 143 million Americans nationwide, and 5.4 million Illinois residents, may have been impacted by the breach of sensitive consumer information. Computer hackers accessed names, social security numbers, addresses and birth dates stored in Equifax’s data systems.

In response to the breach, consumer advocates urged any potential victim to contact the credit reporting agencies and apply for a “credit freeze” on their personal fi-

nances. A freeze would help prevent identity thieves from fraudulently opening new credit accounts. But each request for a freeze cost the consumer at least \$10.

“Illinois residents should not have to pay a fee because of the negligence of a credit reporting agency,” Cunningham said. “It is simply unconscionable that a company would charge consumers any fee after they failed to protect their personal information.”

The legislation Cunningham is proposing, HB 4095, would prohibit any credit reporting agency from charging fees to consumers who request freezes on their credit. Similar legislation has already passed in seven states.

Cunningham is working with Attorney General Lisa Madigan on the legislation. Madigan is leading a multistate investigation to address the consumer harm, taking steps to

help prevent such financial disasters in the future, and hold Equifax accountable. Earlier this month, Madigan joined with 37 other attorneys general to urge credit reporting agencies Experian and TransUnion to immediately stop charging fees to consumers who want to put a credit freeze on their accounts. All three credit agencies would be required to stop charging fees in Illinois if HB 4095 becomes law.

Attorney General Madigan encourages people to contact her Identity Theft Hotline at 1 (866) 999-5630 or to review the Identity Theft resources on her website, illinois-attorneygeneral.gov. The hotline is staffed with identity theft experts who can help victims report the crime to local law enforcement and financial institutions, work to repair their credit, and prevent future theft. Hotline operators can also assist callers who want to take proactive steps to prevent their personal information from being stolen.

“With tax season quickly approaching, I want to help connect area families with valuable tax credits and exemptions,” Burke said. “I understand how ever dollar counts, and missing out on these credits can cost residents hundreds or even thousands of dollars in higher taxes.”

Burke, Hurley, and Cunning-

ham’s Income Tax Seminar will feature Carol Portman, president of the Taxpayer’s Federation of Illinois, and Ralph Martire, executive director of the Center for Tax and Budget Accountability, who will discuss tax credits and exemptions residents can qualify for to help keep more of what they earn. Burke opposes efforts by Donald Trump and Republicans in Congress to slash taxes for millionaires and billionaires, while eliminating tax deductions that benefit middle-class Illinois families. It is estimated that Trumps moves to weaken

the middle-class would cost Cook County families over \$4,000 a year. In response, Burke is collecting signatures opposing Trump’s tax increase on middle-class families.

“Middle-class families are already struggling under skyrocketing property taxes, and they should not be paying for the ultra-wealthy to get a tax break,” Burke said. “If you agree that the wealthy need to pay their fair share, please sign my petition to demand that Trump and his millionaire friends lift-up the middle-class.”

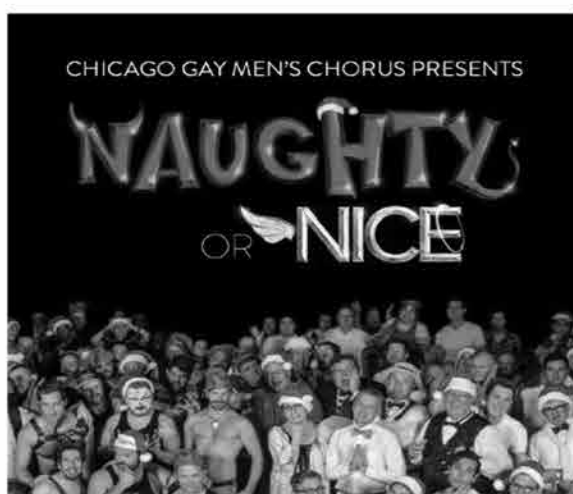

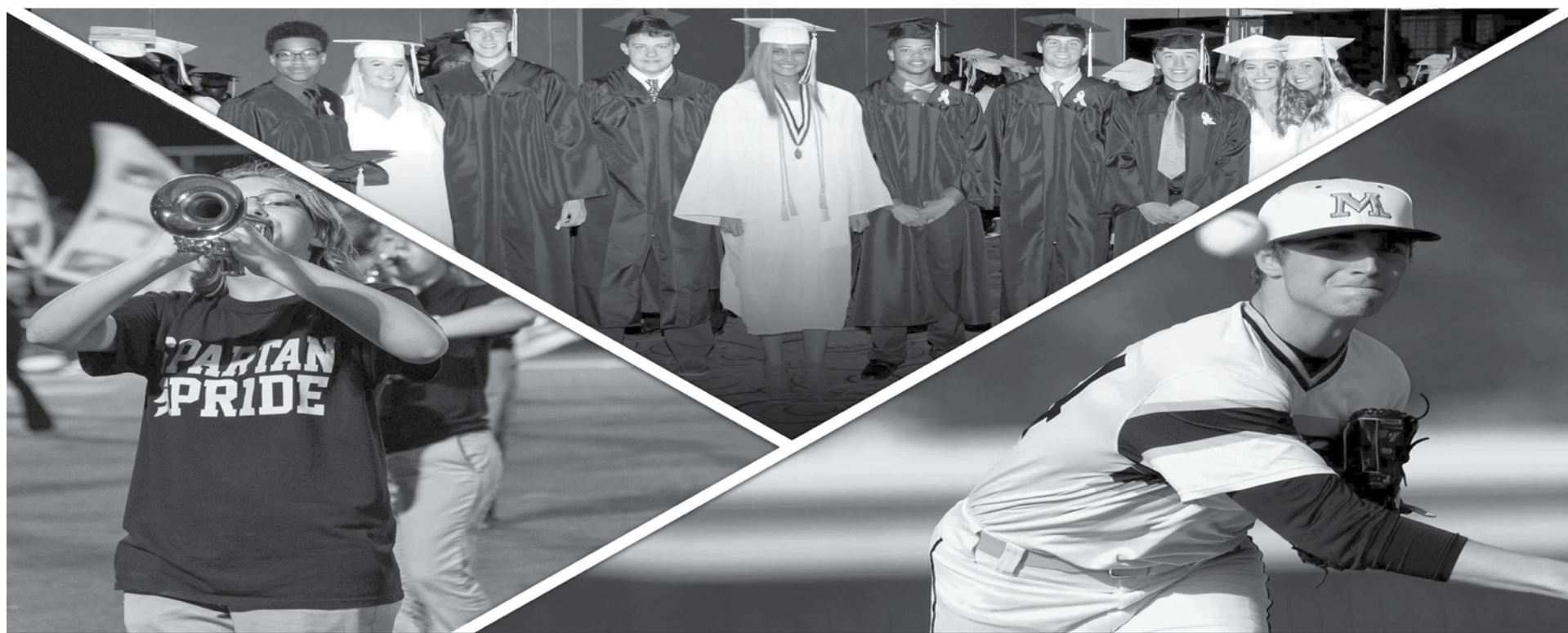

Smith Village Residents Support Neighbors in Variety of Ways

With Thanksgiving just around the corner, it's natural to think about ways to give thanks and give back to others. For years, residents of Smith Village have found imaginative ways to express gratitude and lend support to members of their 19th Ward community as well as others.

This past year, volunteer efforts of Smith Village residents included working with St. Cajetan students and Alderman Matt O'Shea's office to make valentines for veterans, performing comedy skits during monthly Open Mic nights at Smith Village, sewing quilts for retired veterans, knitting caps for premature babies, working with local churches to feed Chicago's homeless, and selling baked goods to raise funds for hurricane relief efforts.

"Smith Village residents always find ways to help others," said Marti Jatis, executive director for the life plan community located at 2320 W. 113th Place. "Sometimes a single resident will spearhead an effort with others lending support. The mix of resident-volunteer efforts constantly changes. Some-

times a specific cause will need immediate attention, or our residents have fulfilled a need and are looking for a new way to help. It's safe to say that at any given time, several Smith Village residents are investing their talent and time in efforts to support others. And, residents in all lifestyle settings have the opportunity to volunteer."

Many residents volunteer within the Smith Village community. Several independent living residents drive fellow residents to medical appointments. Others volunteer in the onsite store, selling snacks, cards, small gifts, personal hygiene products and cleaning supplies to raise money for Emile's Fund to ensure residents who outlive their means will never have to move.

"We are a true community of supportive neighbors," said Gene Sablick, Smith Village resident council director.

Through a horticulture therapy program, skilled nursing care residents have made flower arrangements and doctored houseplants later sold to raise money for Emile's Fund.

Independent living residents have hosted Souper Bowl parties to collect funds for the Morgan Park Food Pantry. Others have made peanut butter and jelly sandwiches for another local food pantry. They've also served meals to families staying at the Ronald McDonald House near Advocate Children's Hospital in Oak Lawn. For now, some of these efforts are on hold, but there's a good chance that new residents will take them up in the future, Jatis said.

For several years, Smith Village resident Marge Murphy organized candy sales to raise money for Misericordia, a community serving people with developmental disabilities. After she passed away in December of 2014, several Smith Village residents volunteered to sell Christmas baked goods made in the Misericordia bakery in her honor.

Through St. Linus Catholic Church, residents in Smith Village's skilled nursing care wing bundle plastic eating utensils in paper napkins for a program that feeds Chicago's homeless. They produce 200 bundles each month to accompany lunches provided through the Port Ministry in Chicago's Back of the Yards neighborhood.

Members of a Smith Village knitting group make hats for the Merchant Marines as well as caps for premature babies.

Over the last seven years, the Smith Village Sewing Club has

sewn coats for greyhound rescue dogs, bibs for adults with learning disabilities, and quilts to raise money for Alzheimer's disease research.

Most recently, the club thanked residents of the Manteno Veterans Home by making 25 lap quilts. A relative of Smith Village resident Dan O'Connell, who passed away in August, added some full-size quilts to the donation.

"Grace Larsen suggested we do this," said Kay Bach, who started the Sewing Club after moving to Smith Village in 2010.

Grace's husband, Edward, now deceased, served as a Marine during the Korean War and later volunteered with Windy City Veterans Association, which supports the veterans home. "We felt it was important to let veterans know we care," said Grace. "My husband helped me realize we should thank veterans for their service." Windy City Veterans Association's Bob Moses delivered the quilts to the Manteno Veterans Home.

In September, Smith Village residents and staff organized a bake sale that raised \$670 in relief for seniors living in retirement communities in Texas affected by Hurricane Harvey.

"Giving to others is an important part of the lifestyle here at Smith Village," said Jatis. "This provides residents the chance to make vital contributions to the outside world and to grow as individuals."
