## CPS Invests \$30 Million in Local Early Childhood Expansion

Alderman Matt O'Shea and Chicago Public Schools recently announced major investments in early childhood education in the 19th Ward. Through this capital investment, the Barbara Vick Early Childhood & Family Center will be expanded at its current location at 2554 W. 113th St.; a satellite location will also be created at 9901 S. Western Ave. This new satellite location will be the third Barbara Vick facility; Barbara Vick Village Early Childhood & Family Center operates at 3001 W. 59th St. In addition to the major expansion of Barbara Vick, a new annex will be constructed at Clissold Elementary School specifically for early childhood education. In total, these projects represent a nearly \$30 million dollar investment in early childhood education.

From language development to overall health, research consistently finds what happens in a child's earliest years is most important for development, growth and long term well-being. Allocation of resources to early childhood programs is critical. Expansion at Barbara Vick is especially impactful because it offers a unique blended classroom environment providing services to young children with developmental disabilities and their typically developing peers.

### Barbara Vick Early Childhood Center:

CPS will construct a new four classroom addition that will also include a new multi-purpose room, two offices, a faculty work room, two storage rooms and updates to the existing main school building. The school will also receive a new parking lot with 47 parking spaces, landscaping improvements, and additional storm water management. Construction is tentatively scheduled to begin this fall and take approximately one year. The budget for this project is approximately \$10 million with a fall 2023 projected opening date.

### New Satellite Location – Barbara Vick Early Childhood Center:

In addition to the major investments at the original Barbara Vick campus, CPS has purchased the building at 9901 S. Western Ave. to renovate into a satellite facility for Barbara Vick. This new facility will include 6 additional early childhood classrooms with office space in the basement and on the second floor. The budget for this project is \$11.65 million with a fall 2023 projected opening date.



### Clissold Elementary School:

CPS will construct a new, stand-alone six classroom annex that will support expanded pre-k and early childhood opportunities for local students. In addition to the annex, Clissold will receive a new play lot at the northwest corner of the campus. The existing four classroom modular will also be fully renovated

as well as the kitchen in the main building. The main building will also receive a new lunchroom. The existing parking lot will be enlarged and include more landscaping and storm water management elements. This project is expected to start in late 2022. The total project budget is estimated at \$8 million.

available for purchase from local food trucks.



## Improvements Coming to Local Parks

Alderman Matt O'Shea and the Chicago Park District recently announced improvements to several 19th Ward Parks. Plans include new lighting for night games at two baseball diamonds and replacement of tennis courts at Beverly Park, installation of a new batting cage at Kennedy Park, and replacement of tennis courts at Mount Greenwood Park. More detailed information on budget and schedule for each improvement can be found below.

**Mount Greenwood Park:** The four tennis courts at Mount Greenwood Park will be resurfaced and re-striped. This project has a \$75,000 budget and is expected to be completed in Fall of 2022.

**Beverly Park:** New field lighting will be installed at baseball diamonds two and three to allow for night games. This project has a budget of \$200,000 and is currently scheduled for completion in Fall 2022.

The four tennis courts at Beverly Park will also be completely renovated, resurfaced and striped. This project also has a budget of \$200,000 and is scheduled for completion in Fall 2022.

**Kennedy Park:** A new baseball and softball practice batting tunnel will be installed at Kennedy Park. The tunnel will include fencing, netting and new ground surfacing. This project has a budget of \$40,000 and will be completed in Fall of 2022.

# O'Shea Ordinance Offering a Death Benefit to Spouses of First Responders Who Die by Suicide

Alderman Matt O'Shea proposed an ordinance at the April City Council meeting that would establish a death benefit for the surviving spouse and family of Chicago first responders that die by suicide. The ordinance was co-sponsored by all 50 Chicago Alderman.

If passed, the ordinance would provide surviving spouses one year of salary, as well as a one-time financial benefit that ranges from \$20,000 - \$40,000 depending on the size of the family. These benefits mirror what the City currently provides to the surviving spouses of first responders who die in the line of duty. The ordinance would apply to families of all active Chicago Police Officers, Firefighters, and

Paramedics, and would be retroactive to January 1, 2018.

First responders are at a much higher risk of experiencing both Acute Stress Disorder (ASD) and Post Traumatic Stress Disorder (PTSD) as a result of frequent exposure to traumatic events. In 2021, there were 632 law enforcement deaths in the United States; nearly 25% of those deaths occurred as a result of self-inflicted injuries. Suicide was the second leading cause of death among law enforcement officers behind only COVID last year. If you remove COVID related deaths, suicide would cause 49% of law enforcement deaths last year.

"First responders experience trauma on a daily basis," said Ald.

O'Shea. "They regularly encounter violence, death, tragedy and loss and are forced to carry those experiences with them in their daily lives. As a direct result of their work, many first responders suffer from ASD, PTSD, depression and other mental health issues. Too often, those issues contribute to tragic acts of suicide. Given that, I believe that the government should provide support to first responder families who lose a loved one to suicide."

The ordinance was supported by Anastasia "Stacy" Escamilla and Julie Troglia. Their husbands, Chicago Police Officers Paul Escamilla and Jeffrey Troglia, together gave more than 30 years of dedicated

service to our city before they took their own lives in 2019 and 2021, respectively. They are each survived by three young children, in addition to their spouses.

"I am grateful to Ald. O'Shea and his colleagues for their efforts to close the gap between officer deaths in the line of duty and suicide. For me and our children, there is no difference," said Julie Troglia. "I hope that bringing attention to first responder suicides will benefit those families, who like us, face daily financial and emotional hardships as we struggle with our grief and loss."

A hearing before the Committee on Finance is expected in June.



# Special Education Art & Music Therapy Pilot Program Offered at Two Area Schools

Special Olympics Chicago/Special Children's Charities (SOC/SCC) has launched a pilot art and music therapy program for diverse learners at four Chicago Public Schools, including Mount Greenwood Elementary and Morgan Park High School in the 19th Ward. The art and music therapy program, which launched in February, is being fully funded by the Special Olympics Chicago/Special Children's Charities program.

Art and music therapy services are presented in partnership with the Institute for Therapy Through the Arts, which is providing a weekly, in-person group art or music therapy session for students in special education cluster programs. The therapeutic artmaking and music programs have been adapted to meet the individualized needs of students at various stages of development. The creative arts therapies provide a platform for self-expression and invite non-verbal individuals to communicate through a creative medium.

Through these sessions, students are given opportunities to play instruments, or use clay or other artistic mediums to express emotions and stimulate new behaviors, which can then be trans-

ferred into everyday life. Students have the opportunity to explore their creativity, better express their emotions, and develop effective tools to communicate and socialize with their peers. Cluster program teachers report that these therapies have had a calming effect and help students to center themselves throughout the day.

The concept for an art and music therapy program was presented to the SOC/SCC Board of Directors by fellow Board Member, Matt O'Shea, after he approached schools within his community as to what could be done to assist special needs students who were suffering as a result of the COVID-19 pandemic.


"Over the last two years, everyone has struggled to maintain connections with people, but particularly those within the special needs community," said Matt O'Shea, Vice-President of the SOC/SCC Board of Directors. "Through programs like art and music therapy, we can address the educational, social and mental health needs of these students. I would like to thank Principal Kate Reidy of Mt. Greenwood Elementary for bringing this idea to SOC/SCC. I hope that we can continue to expand

this important program, and help our diverse learner students recover some of the experiences they lost over the past few years."

SOC/SCC provides year-round programming and events to thousands of athletes within the city who have intellectual disabilities, and participate in Special Olympics programs through the Chicago Park District and Chicago Public Schools. In addition to sports, SOC/SCC also funds cultural institution partnerships, arts programming, an athlete-produced cable access television show, cooking nights, dance parties, special events, field trips, and more.

Most recently, SOC/SCC an-

nounced the funding of an all-new partnership with Anixter Center and City Colleges of Chicago called "After 22". This program provides a college experience for individuals with developmental and intellectual disabilities. Participants have the opportunity to attend college courses at Daley College that help them advance their education and develop job skills. Through the program, each student has access to staff support to help them identify additional opportunities outside the classroom based on their interests. Ultimately, students will be placed in internships, jobs, or other programs centered on sports or recreation.

# O'Shea Co-Sponsors Ethics Reform Package

Alderman Matt O'Shea joined Alderman Michele Smith and the Chicago Board of Ethics in co-sponsoring a legislative package that will significantly strengthen Chicago's ethics laws. The package, authored by Alderman Smith, targets four key areas of ethics reform: Ethics Violation Fines, Conflicts of Interest, City Council Privilege, and Campaign Finance.



Under this proposal, existing fines for substantive ethics violations would be increased fourfold with a new range of between \$1,000 and \$20,000 per violation. This increase will send a strong message that the City is serious about reform and that those who would disregard regulations will be held accountable.

The package also includes provisions that strengthen existing laws around conflicts of interest in nepotism. For example, under the current ethics laws, City employees and Elected Officials are barred from managing contracts if they have a spouse or relative is employed by the vendor. Under the new proposal, employees and elected officials would be prohibited from involvement with any administrative or legislative action

including any issues related to permitting, licensing, or city inspections.

City Council members are currently required to recuse themselves from votes where a conflict of interest may exist. However, an Alderman choosing to recuse him or herself from voting, is still permitted to be present for, and participate in debate on the matter. Under this proposal, any elected official, including

the Mayor, City Clerk, or Treasurer, who has a conflict of interest on a particular item would be required not only to recuse themselves from any formal action, but also physically leave the room for any discussion or debate.

Finally, the package expands existing campaign contribution limits. Current provisions are imposed on vendors doing work for the City of Chicago. Under this proposal, that cap would extend not only to vendors doing work for the City, but also any sister agencies like the Chicago Park District, Board of Education etc. In addition, is also imposes this cap on subcontractors working for the primary vendor, closing a major loophole.

Offices on the ballot include U.S. Senator, all Illinois Statewide Officers, all Representatives in Congress, various State Senators and State Representatives, Commissioners of the Metropolitan Water Reclamation District of Greater Chicago, Commissioners to the Cook County Board and Board of Tax Review, and several County-

wide Offices include Board President, County Clerk, Sheriff, Treasurer, and Assessor. There will also be several judicial positions on the ballot.

# Tech Tuesdays Return to Smith Village

Free, 3-week series to share tips and techniques so seniors can master their smart- phones, Tuesday mornings starting June 7

Tech Tuesdays, a free, three-part series sponsored by 19th Ward Alderman Matt O’Shea, the Beverly Area Planning Association and Smith Village, will help seniors learn more about how to use a variety of features for smartphones and tablets. Tech Tuesday aims to help adults use more of the features of their digital devices.

Please be sure to indicate the kind of digital device you use.

“Smartphones and tablets can

be incredibly helpful, yet often even experienced users only master a few features instead of leveraging the power of what we hold in our hands,” says 19th Ward Alderman Matt O’Shea. “These classes can help participants use their devices more effectively.”

With the goal of providing specific instructions and hands-on assistance, one classroom will be set up for participants using Apple

products including iPhone, iPad and iPod Touch and a second room for Android users including Nokia, Motorola, Samsung and Google devices.

Those attending the classes will learn how to use FaceTime, WhatsApp and Zoom, as well as how to set up email and text groups to stay in touch with friends and family. Additionally, classes will explore safety and security concerns about

how to keep information private and avoid scams. Finally, seniors will learn how to find and install applications, or apps, including some of the most popular and useful apps for older adults.

All participants must bring their own devices so they can immediately apply what they’re learning to their own smartphones and tablets. “Smart- phones and tablets are woven into everyday life,” says Smith Village executive director Marti Jatis. “We are pleased to host this series because we know first-hand how important it is for older adults to stay in touch and to expand their understanding of the devices that most already have.”

Plan to arrive as early as 10am to visit with neighbors and to enjoy Smith Village’s hospitality.



## Save Money with a Water Meter Today

The City of Chicago is expected to resume the installation of Water Meters this Summer. Water meters are a great way to conserve water and save money. If your home does not have a water meter, your water bill is based on a formula tied to the size of your property rather than your actual water consump-

tion. By signing up for a meter you will be billed only for the water you use.

On average, home owners who install water meters see a 25% reduction in water bills. The water meter will also allow you to reduce your water bill by reducing your water usage. Most importantly,

any home that installs a water meter receives a guarantee that regardless of water consumption, your bill will not be higher than it was without a meter for at least seven years!

There are currently 11,000 Chicagoans on a waiting list for water meters. If you have already re-





## Hurley Passes Legislation on Suicide Prevention

To help address the burgeoning mental health crisis across Illinois, state Rep. Fran Hurley passed a bill to create a new suicide prevention hotline. Hurley carried Senate Bill 2945 in the Illinois House of Representatives, which creates a statewide 9-8-8 trust fund to support the successful launch and operation of this vital service.

"The mental health care system is complicated and hard to navigate, especially for people in crisis. The 9-8-8 hotline provides an easy way for people to access the life-saving care they need," said Hurley. "Funding the 9-8-8 is an integral first step in creating a comprehensive mental health crisis system in Illinois, and I look forward to further collaborating with stakeholders to make sure these essential services are funded and accessible."

According to the Illinois Department of Public Health, suicide is the 11th leading cause of death in Illinois, resulting in more than 1,000 deaths each year. For young people ages 15 to 34 years old, suicide is the third leading cause of death in the state. The goal of the 9-8-8 hotline is to de-escalate mental health emergencies and ensure those who are experiencing a mental health crisis get the services and

care they need. The Statewide 9-8-8 Trust Fund created by Senate Bill 2945 will establish the 9-8-8 hotline so the service can provide adequate intervention and care across the state.

"Suicide is preventable, but many people do not seek the care they need because of the stigma and feelings of shame surrounding mental health. By funding the 9-8-8 hotline, we're furthering the conversation around mental health and suicide prevention which has the potential to save lives," Hurley said. "It is always okay to ask for help, and the 9-8-8 hotline will be an easy way for people to do so. I am incredibly proud of the General Assembly for voting to fund this vital service, and I thank my colleagues on both sides of the aisle for their support. In October of 1976, my 18 year old brother Bob committed suicide. If this number was available back then, would he still be around today? I would like to think yes."

The 9-8-8 hotline will roll out in July 2022, according to the Illinois Department of Human Services. Senate Bill 2945 passed with unanimous support out of the House of Representatives, during the 2022 spring session of the 102nd General Assembly.

## Middle Class Families to Receive Tax Relief

A typical family of four in Illinois is set to receive approximately \$600 in direct tax rebates thanks to the Fiscal Year 2023 budget just passed by the General Assembly, according to State Senator Bill Cunningham.

"Not only were we able to pass a balanced budget, but we had a surplus in revenue, which enabled us to return money to the hard working taxpayers who generated the funds in the first place," Cunningham said. "Given the new inflation-related financial burdens we are facing, this tax relief couldn't come at a better time."

In total, the state will provide more than \$1.8 billion in direct rebates to working families. One of the largest breaks will go to those who pay property taxes. Homeowners who earn up to \$250,000 individually, and joint-filers earning up to \$500,000, are eligible for property tax rebates up to \$300 per household.

Income tax rebates will also be provided. Individual tax filers will receive a \$50 rebate and joint-filers will receive \$100. Additionally, families will receive \$100 for each dependent (up to a maximum of 3 children.) As such, an average family of four in the 19th Ward will receive a total of \$600 in rebates. The payments will be sent by check to each household in late-Summer/early-Fall.

But the property and income tax breaks aren't the only tax relief Illinois residents are due to receive thanks to

the new state budget. The state sales tax on groceries will be suspended for a year, saving consumers a total of \$400 million.

To provide relief from record high gas prices, the state's motor fuel tax will be suspended for six months, saving consumers \$70 million. And a temporary suspension of sales taxes on school supplies will be enacted in August to help families doing back-to-school shopping, saving consumers \$50 million. Additionally, teachers will be given help to buy supplies for their classroom through a tax credit of up to \$500.

Cunningham, who is one of the state senate's lead budget negotiators, said this year's budget is a break from the bad habits of previous General Assemblies.

"In the past, when the state collected surplus tax revenue because of a strong economy, those dollars were often spent on new government programs. Not this year," Cunningham said. "We used surplus dollars to pay-off old bills, reduce pension debt, and create a 'rainy day fund' for future fiscal emergencies. And we took what was left and returned it to the taxpayers."

Shortly after the budget passed, Moody's, the nation's leading credit rating agency, boosted Illinois' rating for the third time in the last 10 months, citing the state's fiscally responsible practices.






